




The following day November 9, 2023, a Conference Proper started at around 9 in the morning. The topic discussed is about the Sustainable Forest Management in the Philippines. In this topic there are four subject matter transpired to includes:

a) Status of Supply and Demand of Wood and NTFP and existing Policies and Tenure in Tree Plantation and NTFP in the Philippines

There is a great demand of wood based industries in the Philippines wherein in order to sustain the level of productivity and/or output there should be a balance between growth and harvest. It means that if there is cutting of trees there should be replacement for every tree cut for the continuity and maintain forest cover without depleting the forest resources of the Philippines.

b) Revitalizing the Wood Industry



The wood industry of the Philippines is boosted by the establishment of Private Tree Plantation, Industrial Forest Management Agreement (IFMA) and Socialized Industrial Forest Management Agreement (SIFMA) as ultimate source of wood industry.

c) Forest Production and Carbon Neutralization

The establishment of private tree plantations and other forms of reforestation like IFMA, SIFMA and under the NGP program of the DENR, tree planting activites and existing foest cover are the main source of carbon neutralization and carbon sequestration.

d) Million - Hectare Forest Program


A lot of hectares is now under the national integrated program of the DENR to cover the National Greening Program (NGP). The new approach introduced by the DENR is the agroforestry approach of rehabilitation of our denuded/barren forest lands.

David, Undersecretary for Integrated Environmental Science, DENR, respectively.



November 10, 2023, topic discussed were the following: a) Redefining the Role of Forester, by Antonio P. 
Topic discussed in the Conference Synthesis Message from Regional Council President and PFEN President, Inspirational Challenge, Hand-over of National Conference Hosting to



### I. EVALUATION OF THE COURSE:

### Technical Content:

- This kind of event is very relevant to the job that the foresters of the DENR are performing. The event was exclusively for Registered Foresters all over the country, most of the participants are from the DENR. With this year's conference theme "Advocating Wood and Non-timber Forest Products Sufficiency for Climate Resiliency", the topics presented were related to the recently trends on the forestry sector such as the following: 1. Status of supply and demand of wood and NTFP and existing policies in tenure tree plantation and NTFP in the Philippines, 2. Revitalizing the wood Industry, 3. Forest production and carbon neutrality.
- The following are some of the notable experts in the industry and other speakers of the conference:
  - **Dr. Manuel L. Bonita** International Forestry Expert
  - Dr. Carlos Primo C. David USEC for Integrated Environmental Science, DENR
  - Dr. Rex Victor O. Cruz Previous UPLB Chancellor; UPLB-CFNR Professor
  - **Mr. Marlo D. Mendoza** Dean, UPLB CFNR; President, Philippine Forestry Education Network
  - Mr. Marcial C. Amaro Jr. ASEC for Internal Affairs; Director DENR-BMB
  - Hon. Erwin M. Enad Commissioner, Philippine Regulation Commission
  - Dr. Antonio P. Contreras Registered Forester/ Professor, UPLB

### **Highlights of the Activities:**

- Plenary Session 1: How can the country attain self-sufficiency in wood and non-timber forest products?
  - The country is highly dependent in wood imports spending about Php40 Billion and wood industry contributing less than 1% to the GDP;
  - Need commitment/passion with responsible environmental management planning, forest and landscape restoration as pathway and key strategies to attain self-sufficiency.

### PROPOSED INITIATIVES:

- Harmonization of policies (e.g. integration of forest lands in the National Cadastre System), guidelines and requirements in issuance of forest tenurial instruments
- Convergence of interest from stakeholders, identification and classification of production forest, private investment on tree farming and deregulation on harvesting and transporting of wood products
- Access to carbon market facilities and adoption of Payment for Environmental Services (PES)
- Million-hectares forest Program with emphasis on role and importance of Forest Management Units

## **Plenary Session 2: Forging partnership with International Forestry Professionals**

- Importance of conferences in building partnership and solidifying with counterparts including forestry concerns that need to be acted upon and put into action by the foresters with the goal of reviving the forestry sector
- Broadening network and learn from experiences/best practices of neighboring countries (e.g. Malaysia and Laos)
- Alignment with Global Forest Goals (GFG)
- Connections among 3 Fs (Forests, Foresters and Forestlands)

## Plenary Session 3: Rekindling the pride in the Forestry Profession: The need for Professionals to strengthen their ranks.

- Importance of strengthening forestry profession, striving for excellence and utilizing technologies while continuously learning and improving;
- Encouraged the mindset of "generalist change the world while specialists perfect it";
- Highlighted that the forestry profession is mandated by law and requires renewal of professional licenses
- Segregated that a resolution to improve and regulate the forestry profession by allowing only licensed and SFFI members RPFs to perform related activities and review policies for further improvement
- Discussed on how be a world class forester
- Shared experiences of being a forester entrepreneur

### **Impressions/Comments:**

• Professional Foresters need this kind of event to update its knowledge on the new trend in the industry not just in the local settings but globally. For this year's conference, the SFFI Officers considered the invitation of experts as speakers from other countries. Global problem needs a global solution, environmental problem like global warming and illegal trade of forest resources and wildlife goes beyond the authority of the Philippine Government. Thus, connections among authorities of the world is necessary to eradicate illegal activities especially those that are directly

affected the environment. Cooperation between countries is very important by sharing its experiences and solutions to attain successful implementation in countering environmental problems and how it will be applied to our country.

• One of the important topics that had been discussed during the conference was about sustainable management and utilization of the country's timber and non-timber forest products in order to contribute to the national economy. This made me realized the need to review the present activities and consider some proposals on development and eventual utilization of timber and non-timber forest products. Some foresters working as conservationist tend to look utilization as destructive and may affects the conservation efforts of the government, thus, overlooked its economic aspects. Based on the perspective of the speakers from private sector, they shared the importance of forest products to the national economy where the other countries are enjoying its benefits.

## II. RELEVANCE OF THE LEARNING EVENT TO PARTICIPANTS WORK/FUNCTION:

• The said event is very relevant to our function as Government Foresters, understanding the new trends and updated environmental related data not only beneficial to the foresters themselves but to the DENR as a whole organization. Continuous acquiring of additional learning of work related knowledge is important to become more competitive and efficient in performing our daily activities. When a government forester is knowledgeable enough on the job, this will transform into a better services to the Filipino People.




DAY 1 November 08, 2023: Travel to location and Registration
