JUDICIAL AFFIDAVIT (of Witness JOANN P. PAZ)

Affiant, by counsel, unto this Honorable respectfully submits this Judicial Affidavit pursuant to A.M. No. 12-8-8-SC of the Supreme Court and avers that:

I. Preliminaries

Affiant, JOANN P. PAZ ("Joann"), is a resident of Narra. Palawan. She is the Forest Technician I/In-charge Records Officer of the Department of Environment and Natural Resources (DENR) Community Environment and Natural Resources Office (CENRO) Quezon, Narra Station.



The examination is conducted by the undersigned notary public through short message service (SMS), electronic mail and at Narra, Palawan.

The undersigned counsel also apprised the Witness that she is under oath and that any untruthfulness can make her liable for false testimony/perjury.

II. Purposes

- a. To show and prove the protest filed by Quirino Acla as early as March 17, 1997 on the application of Proyekto Tan Paredes, the father of John Tan Paredes as to Lot 855-G, CSD-4A-001234-D located at Taritien, Narra, Palawan.
- b. To show and prove that Proyekto Tan Paredes committed fraud and misrepresentation when he did not reveal that he has other properties when he filed his application for the subject lot; and, when he made it appear in his application that he owns the house on the property.
- c. To show and prove that John Tan Paredes knows of the presence of Quirino Acla on the subject property as he was present during the meeting on September 21, 2004 at 2 o'clock in the afternoon before the Office of the then DENR-CENRO Narra (now, DENR-CENRO Quezon, Narra Station).
- d. To show and prove that there was no record of any final decision on the protest filed by Quirino Acla.
- e. To show and prove that John Tan Paredes, not Proyekto Tan Paredes, was granted an application for free patent on the same property being claimed by Quirino Acla.
