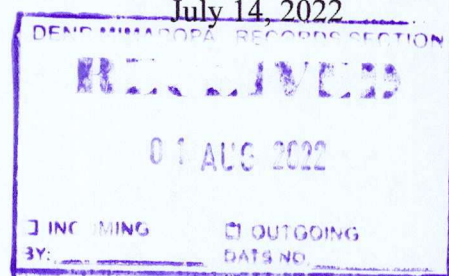

Based on our records, there is no existing approved Provisional Agreements for all tenure under forestry sector within the administrative jurisdiction of this office.

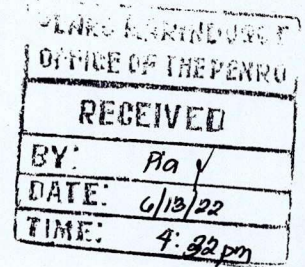
