









HIGHLIGHTS

Lionheart Farms (Philippines) Corporation (LFPC) seeks to conserve the remaining forest through protection, reforestation of denuded areas, assisted natural regeneration (ANR) of remaining forest, and secure the protection and maintenance of planted trees.

The Forest Protection project also aims to achieve the following:

- (1) Compliance with the JVA requirements;
- (2) Strengthening existing collaboration(s) with the MENRO, PCSD, DENR, Municipal LGU, and Local Government Units (LGU) of Ransang and Candawaga, Rizal and other local communities and partners especially with the protection and reforestation of the denuded forest;
- (3) Supporting the National Greening Program of the Government (NGP);
- (4) Further enhancement of the awareness and capabilities of the local communities in the protection, reforestation of denuded forest and establishment of endemic fruits & trees, and high value fruit tree plantation;
- (5) Effective mobilization of local communities towards the protection of the remaining forest and establishment of high value fruit tree plantation; and
- (6) help improve the living condition of IP's and non-IPs through the promotion of raising the indigenous tree and fruit tree seedlings.

For this month of MAY 2022, the Lionheart Farms (Philippines) Corporation (LFPC) has accomplished the following activities:

- a. From 1st week to last week of May 2022, the Lionheart Farms (Philippines) Corporation assign staff in Forest Tree Nursery continued doing their activities such as weeding, watering and application of organic foliar fertilizer and pesticide to the seedlings to eliminate and prevent the attacked of pest and diseases also providing the food for young seedlings before out-planting. *(Please see photos attached as **ANNEX A**)*
- b. 1st week of May 2022, Lionheart Farms (Philippines) Corporation staff assign in agroforestry project conducted a planting of collected Bamboo cutting in Sitio Malaka-laka, Bgry. Campong-Ulay, Rizal, Palawan. A total of six hundred ninety-three (693) Bamboo cuttings were planted. The purpose of bamboo plantation establishment in sitio Malaka-laka is to increase the carbon sequestration of the area and additional source of bamboo ladder for coconut tapping. *(Please see photos attached as **ANNEX B**)*

- c. Last week of May 2022 the LFPC staff assign in agroforestry project conducted of tree planting activity in Sitio Tagbalugo, Barangay Culasian, Rizal, Palawan. The tree planting activity was participated by local community, IP students, LHPC staff from Gabay Kalinga and Farm Operation Department. A total of one thousand (1,000) forest trees seedlings were planted like Ipil (*Instia Bijuga*), Mahogany (*Swietenia macrophylla*) and Rambutan (*Nephelium lappaceum*). The number of seedlings out-planted are the following: for Mahogany (*Swietenia macrophylla*) Seedling was out-planted of five hundred (500) followed by Ipil (*Instia Bijuga*) Seedling of four hundred and followed by Rambutan (*Nephelium lappaceum*) Seedling of one hundred (100). The planting was held at Sitio Tagbalugo, Culasian Riverbank. *(Please see photos attached as ANNEX B)*
- d. Last May 2022, Lionheart Farms (Philippines) Corporation's Foot Patrol Unit continued conducting regular monitoring of illegal activities inside the JVA and adjacent areas. Based on the report made by the Foot Patrol Unit, there is no trace of the illegal poachers of wildlife and loggers monitored in the vicinity and neighbor of Lionheart area because of the **COMPANY PROGRAM** like hiring of person involved on the illegal activities and also the presence of concern agencies like CENRO, KSK field staff and barangay. *(Please see photos attached as ANNEX C)*
- e. Last May 2022, Lionheart Farms (Philippines) Corporations staff assign in agroforestry project conducting a Maintenance of Bamboos Planted in at Maruso, Ransang last 2021. The team finished a round weeding and strip brushing and inventory of planted bamboo. Out of two thousand two hundred ninety (2,290) bamboo planted only one thousand one hundred ninety-two (1,192) or fifty-two (52) percent (%) were survived and one thousand ninety-eight (1,098) or were dead. Those planted bamboo dead will replace this coming June 2022. *(Please see photos attached as ANNEX D)*




