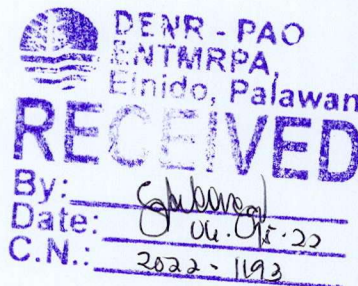

Please be informed that on May 31, 2022, the El Nido-Taytay Managed Resource Protected Area (ENTMRPA), El Nido, Palawan spearheaded a meeting with the enforcement partners and stakeholders in coordination with Community Environment and Natural Resources Office (CENRO) Taytay, Palawan held at Bgy. Cafeteria, Maligaya, El Nido, Palawan.

It was participated by a total of thirty (30) representatives from 23rd Marine Company, Philippine Coast Guard (PCG), Municipal Environment and Natural Resources Office (MENRO), Joint Task Force Malampaya (JTFM), Malampaya Foundation Inc (MFI), Vendors Association, People's Organization (PO) *Pagkakaisa, Pagtutulungan, Kalikasan Pakaingatan (PPKP)*, Municipal Fishery and Aquatic Resources Management Council (MFARMC), ENTMRPA Staff and CENRO-Taytay staff.

During preliminaries, Mr. Rodel M. Dorado acknowledged the presence of everyone, CENRO Alan L. Valle welcomed the attendees. It was followed by the presentation of Mr. Steven John Andao regarding ENTMRPA Profile. Mr. Voltaire Delos Angeles shared the salient provisions of Presidential Decree (P.D) 705 "Forestry Code of the Philippines".

Moreover, Enforcement Management Section (EMS) Chief Dennis Aldrin Velasco presented the apprehensions of the team with the partner agencies since 2021 to date. CENRO Alan L. Valle also presented the Environmental Laws and Policies of ENTMRPA such as NIPAS Act (RA 7586) of 1992 as amended by ENIPAS Act (RA 11038) of 2018, Presidential Decree (PD) 705 of 1975, Presidential Decree No. 1067, s. 1976, Proclamation No. 2152, s. 1981 and other relevant laws.

It was followed by Mr. Ebenezer Herrera, he discussed the drafted work plan with budget details for the year of 2018-2022. Audio-visual presentations on LAWIN CyberTracker Technology are also displayed.

After the presentations, Assistant Protected Area Superintendent (APASu) Jenuel P. Casel facilitated the forum. The following are the agreements during meeting:

1. MFI will facilitate the next meeting;
2. MENRO committed to assist on monitoring and speed boat with fuel;
3. JTFM are also willing to provide manpower and vehicles if needed;
4. 23rd Marine Company will assist and their truck if needed;
5. PCG assured that they are willing to assist with their floating assets.
6. FPMS will be extending their support on intensifying the enforcement patrols.
7. On Next meeting, all agency is required to present their environmental activities conducted.
