ORDER

Before this Office is the Memorandum for the Secretary dated 05 July 2022 of the Regional Executive Director (RED) of DENR-Region IV-B (MIMAROPA Region), requesting for confirmation of the Decision dated 26 July 2018 of the RED, finding respondent Christine P. Olayta, Planning Officer II of the PENR Office (PENRO) of Romblon, guilty of the charges against her and imposing the penalty of dismissal from the service with its accessory penalties, the dispositive portion of which reads:

> WHEREFORE, premises considered, respondent Christine P. Olayta, Planning Officer II of PENRO Romblon, is found GUILTY of Serious Dishonesty, Falsification of Official Document, Grave Misconduct, and Conduct Prejudicial to the Best Interest of the Service, warranting her DISMISSAL from the service, with forfeiture of all retirement benefits, perpetual disqualification from holding public office and bar from taking civil service examinations.

SO ORDERED.

Considering that the penalty imposed shall only be executory after confirmation by the Department Secretary, this Office hereby orders the following:

The RED of DENR-MIMAROPA Region shall submit 1. to this Office proof that respondent Olayta was



furnished a copy of his Decision dated 26 July 2018 indicating the date respondent Olayta received such Decision; and,

2. The RED shall transmit to this Office the complete records of the case, arranged in chronological order, within 15 days from receipt of this Order.
