Ganan is requesting for the correct status of the above mentioned lot and he attached the letter dated March 9, 1971 (except the BF skecth Romblon PMD 98) of Jose Viado (Acting Director of Forestry) declaring that the land covered by the said lots are alienable and diposable.

The Director of Lands

Sir:

I wish to inform you that the tract of land situated in Pag-alad, San Andres, Remblon, containing an area of approximately 40.00 hectares, as shown and described on the attached BF sketch, Romblon PMB No. 98, desired by Atty. Nemesio V. Ganan, Jr., San Andres, Romblon, to be released for agricultural purposes, is within the Timberland Block-A of LC Project No. 4 of Despujols, Romblon, per BF Map LC-660. However, since the said area is no longer needed for forest purposes, the same (the 40.00 hectares shown on Romblon PMD No. 98) is, therefore, hereby certified as such and released as Alienable or Disposable land for disposition under the Public Land Act subject, nevertheless, to the following conditions:

1. There are reserved as timberlands in the area herein certified as not needed for forest purposes a strip of 15 meters in width from the center, and on each side of any public trail therein used as outlet for timber and other forest products and a strip of 40 meters in width from the highest bank on each side of any stream for stream bank protection, pursuant to the provision of Republic Act No. 1273, hereunder quoted as follows:

"That the applicant agrees that a strip of forty meters wide starting from the bank on each side of any river or stream that may be found on the land applied for, shall be demarcated and preserved as permanent timberland to be planted exclusively to trees of known economic value, and that he shall not make any clearing therein or utilize the same for ordinary farming purposes even after patent shall have been issued to him or a contract of lease shall have been executed in his favor."

In this connection, attention is invited to the policy of the Secretary of Agriculture and Natural Resources that the land should be subdivided for not over three (3) hectares each lot, subject to private rights, if any there be, for allocation to landless applicants in the region.
