In compliance with the memorandum from Regional Executive Director Lormelyn E. Claudio, *CESO IV* and in celebration of Philippine Environment Month 2022 with the theme "Aksyon Para Sa Natatanging Mundo", the DENR-CENRO Puerto Princesa (Conservation and Development Section – NGP Unit and IEC Unit) together with PENRO Palawan (NGP and IEC Units) jointly conducted the Nationwide Simultaneous Tree Planting on June 08, 2022 at the graduated National Greening Program (NGP) site located within Iwahig Prison and Penal Farm (IPPF) in Barangay Montible, Puerto Princesa City.

The said activity was participated by a total of two hundred twenty-seven (227) covering one hundred twenty-seven (127) males and ninety-nine (99) females coming from different agencies/organizations which includes DENR-PENRO Palawan, CENRO Puerto Princesa, Puerto Princesa City ENRO, Palawan Council for Sustainable Development and Staff (PCSDS), Local Government of Barangay Montible, Puerto Princesa City Water District (PPCWD), DENR-EMB PEMU Palawan, Puerto Princesa Subterranean River National Park (PPSRNP), Bureau of Correction-Iwahig Prison and Penal Farm (BUCOR-IPPF), Western Command (WesCom), Philippine Coast Guard (PCG), Katala Foundation, Inc. (KFI) and International Association of Youth and Students for Peace (IAYSP). Miss Philippines Earth – Palawan, Christine Glory H. Balboa also graced the event.

At around 6:00 AM, participants started to arrive at the site. The first part of the event was a program which began with an opening prayer led by Fr., Col. Leo C. Balanlay of Western Command, then followed by the singing of National Anthem. A welcome message was given by Hon. Fervi Jane M. Abonales, Chairperson, Barangay Montible. Sr. EMS/Chief, CDS Ma. Vivian O. Soriano of CENRO Puerto Princesa, as the event host provided facts and information about the event and on Presidential Proclamation No. 237 Series of 1988 which declares the month of June as Philippine Environment Month which aims to recognize importance of instilling environmental awareness and concern among various sectors of the society. She also highlighted the efforts toward protection and sustainable use of natural resources through collective act.

During the program, inspiring messages were also delivered by representatives of the following invited partner agencies/guests: Ms. Christine Glory H. Balboa, 2022 Miss Philippine Earth-San Vicente Palawan; PDO IV/Director Nino Rey Estoya of Palawan Council for Sustainable Development and Staff (PCSDS); Senior Environmental Management Specialist Zorina C. Arellano of City ENRO; Penal Supervisor Darwin Madarcos of Montible Sub-Colony - BUCOR-IPPF; and Capt. Boyd Amorado PN (GSC) of Western Command. Verian of CENRO Puerto Princesa which he stressed-out his grateful and appreciation to partner agencies/stakeholders whose continuously gave their full support to the project and programs of the DENR particularly on the protection, rehabilitation and conservation of the environment.

Further, video and photo documentations using drone and geo-tagging device were undertaken all throughout the activity in order to capture the whole event. In compliance to IATF guidelines, minimum health protocols such as wearing of face mask and social distancing were observed during the conduct of activity.

Closed monitoring and replanting during and after program were conducted by the NGP personnel to ensure that all the seedlings were properly planted and achievably grown.




