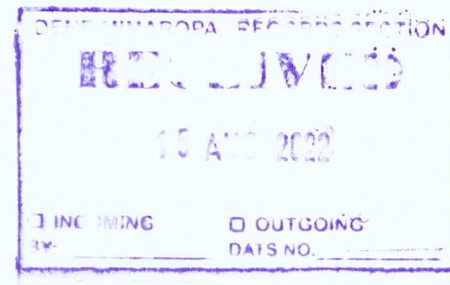

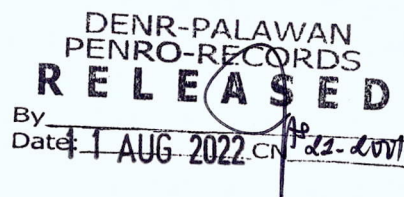
Forwarded is the memorandum dated July 26, 2022 of CENRO Puerto Princesa City along with the report on Philippine Cockatoo nest and habitat monitoring within Iwahig Prison and Penal Farm (IPPF) at Barangays Montible, Sta. Lucia and Sta. Lucia-Luzviminda, Puerto Princesa City that serves as **Means of Verification (MOV)** to the target activity under Conservation of threatened species – Philippine Cockatoo.

Based on the report, four (4) nest trees were monitored and visited consisting of two (2) sites in Sta. Lucia part of Barangay Luzviminda and two (2) sites in Barangay Montible: Menor and Tagtalaba. Likewise, in order to document any possible activity occurring in the sites, the KFI team led the installation of camera traps in one of the Apitong nest trees located in Sitio Menor, Barangay Montible. The team observed a Philippine Cockatoo and Blue-naped Parrot laying eggs on the same nest trees.

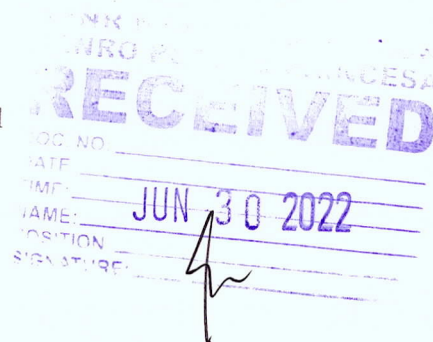



Please be informed that the undersigned joined the team of KFinC. in the conduct of nest habitat and monitoring of Philippine Cockatoo on June 27-28, 2022 within the lowland forested area of IPPF-BUCOR at Bgry. Sta. Luzviminda and Montible, PPCity.

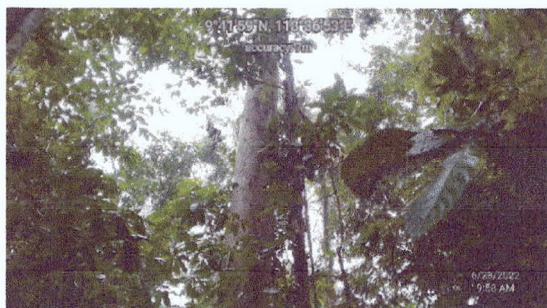
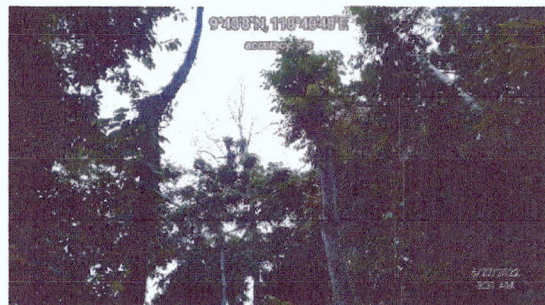
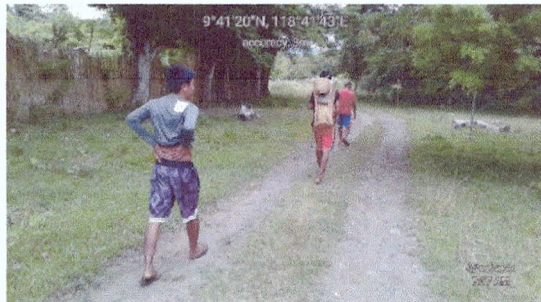
On June 27, 2022 our team proceeded at the lowland forest area of Bgy. Sta. Luzviminda two (2) nesting site Bayoso trees were identified which approximately 90-100 cm. dia. which to checked/monitored laying eggs on the two (2) nesting tree but no signed of eggs found of the said nesting site. On June 28, 2022 the team continued nest habitat and monitoring of Philippine Cockatoo at the lowland forest area of Montible then we proceeded to Menor area one (1) Apitong nesting tree of 80 cm. dia. was installed by a camera trap for documentation according to KFI and two (2) IP's hired tree climbers there are two species of wildlife identified Parrot and Cockatoo laying eggs on Apitong tree. Then the team moving down to lowland forest of Tagtalaba area closed to Montible river one (1) Apitong tree nesting site also monitored and no eggs found at nesting tree. During that time we encountered heavy rains. The team decided to move back due to posing risk crossing the river.
