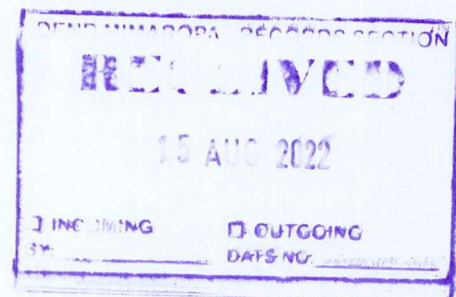



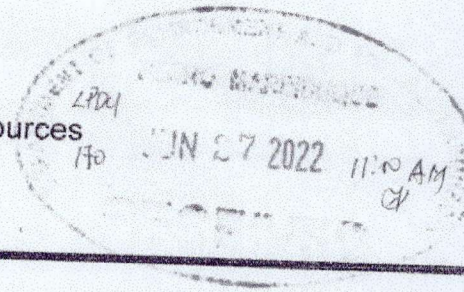

This refers to your Memorandum dated December 6, 2021 forwarding the case folder of the above-mentioned subject docketed as PENRO Case No. 2021-001, ADR Case No. 2021-001 involving a parcel of land situated in Barangay Maligaya, Boac, Marinduque.


Perusal of the case folder shows that an Order of Failure of ADR Proceedings was issued by your Office on June 21, 2021 terminating the ADR Proceedings and advising the Claimant/Protestant to file a verified protest within sixty (60) days from receipt thereof. Copies of the said Order were sent to the concerned parties via registered mail on August 9, 2021.

Registry Receipt No. RE 455 906 400 ZZ shows that Ms. Lynette M. Mantawid received the Order on August 11, 2021 at 10:00 AM. Consequently, she filed a Formal Protest on October 5, 2021. However, the Claimant/Protestant failed to submit any proof of payment of the Protest Fee.

Upon a careful evaluation of the documents at hand, it appears that the formal protest was filed within the sixty (60) days prescribed period, the last day of which falls on October 10, 2021.

In view of the above, it is hereby advised that the Claimant/Protestant Lynette M. Mantawid be given five (5) days to pay the Protest Fee, otherwise, the Formal Protest dated October 5, 2021 should be dismissed pursuant to the provisions of DAO 2016-31.
