RESULT OF ADMINISTRATIVE CONFISCATION PROCEEDINGS OVER THE APPREHENDED TEN (10) PIECES OF GMELINA LUMBER WITH A TOTAL VOLUME OF 57.6 BOARD FEET LOCATED IN PARANCAY MALIRACO, TORRIJOS, MARINDUOLIE

BARANGAY MALIBAGO, TORRIJOS, MARINDUQUE

Respectfully forwarding, the report of Forester I Don Gibson D. Mercado, In-Charge Monitoring and Enforcement Section dated 22 of March 2022, regarding the above-mentioned subject.

This proceeding stemmed from an incident on 31 January 2022 at around 4:00 in the afternoon wherein personnel of the Protected Area Management Office, received a mobile phone call from a concerned citizen from Barangay Malibago, Torrijos, Marinduque regarding the cutting of Gmelina trees at the said barangay.

Accordingly, coordination was immediately made by our Office to verify any issued permit in the said area but to no avail. In relation to this, the team coordinated with Sangguniang Barangay of Malibago, Torrijos, Marinduque regarding the apprehension of illegally found forest products at the above-mentioned barangay.

During the initial investigation, an abandoned forest products (lumber) was left in the area. Upon scaling it was found to be 10 pieces Gmelina lumber with a total volume of 57.6 board feet. Barangay Officials of Malibago provided services for hauling, and the custody of same was temporarily left under Brgy. Kagawad Eulogio P. Fellizar of Barangay Malibago, Torrijos, Marinduque for safekeeping, pending the conduct of Administrative Confiscation Proceedings in accordance with DAO 97-32.

Pursuant to Section 8 of DAO 97-32, the prepared notices of apprehension dated February 04,11 and 23, 2022 was posted by the Forest Officers at conspicuous area in the Barangay Hall of Malibago, Torrijos, Marinduque and apprehension site. This is to inform the general public of such apprehension and to determine the legal owner of said undocumented forest products. The subject posting started on February 04, 2022 and ended up to February 23, 2022. After the prescribed period, nobody claim ownership on such undocumented forest products, hence, it is considered as "abandoned".

Relative thereto, the apprehending officer issued a certification to prove that the notices of apprehension were posted at different places as part of due process, but nobody claim ownership over the said forest products.

In view of this, we recommend the issuance of **Confiscation Order** on the subject undocumented forest products in favor of the government and to immediately dispose the same to avoid loss of its economic value.

Please be informed that on 31 January 2022 at around 4:00 in the afternoon, personnel of Protected Area Management Office (PAMO) of this Office received a mobile phone call from a concerned citizen from Barangay Malibago, Torrijos, Marinduque regarding the cutting of Gmelina trees at the said barangay.

Coordination was made to our Office to verify any issued permit in the said area but to no avail. In relation to this, the team coordinated with Sangguniang Barangay of Malibago, Torrijos, Marinduque regarding the apprehension of illegally found forest products at the above-mentioned barangay.

Meanwhile, during the initial investigation, there was no one in the area who claimed its ownership. Upon scaling it was found to be 10 pieces Gmelina lumber with a total volume of 57.6 board feet. Barangay Malibago provide services for hauling, the custody of same was temporarily left under Brgy. Kagawad Eulogio P. Fellizar of Barangay Malibago, Torrijos, Marinduque for safekeeping, pending conduct of Administrative Confiscation Proceedings in accordance with DAO 97-32.

With that, and pursuant to Section 8 of DAO 97-32, the undersigned had prepared notices of apprehension dated February 04,11 and 23, 2022 and posted by the forest officers at conspicuous area such as Barangay Hall of Barangay Malibago, Torrijos, Marinduque and at the apprehension site. This is to inform the general public of such apprehension and to determine the legal owner of said undocumented forest products. The subject posting started on February 04, 2022 and ended up to February 23, 2022 within the prescribed period, nobody claim ownership on such undocumented forest products, hence, the undersigned considered that as "abandoned".

Relative thereto, the apprehending officer issued a certification to prove that the notices of apprehension were posted at different places as part of due process, but no laid claim ownership. Further, considering the circumstances given above, the undersigned is recommending for the issuance of confiscation order on the subject undocumented forest products in favor of the government and to immediately dispose the same to avoid loss of its economic value.

SINAMBAHAN, BRGY. MALIBAGO, TORRIJOS, MARINDUQUE

Please be informed that on January 31, 2022, at around 12:30 PM, PMF Roderick S. Villanueva from PAMO Satellite Office received a mobile phone call from a concerned citizen from Barangay Malibago, Torrijos regarding an alleged illegal cutting of Gmelina trees at Sitio Sinambahan of the said barangay. Accordingly, the said incident occurred within the private lot of Mrs. Minda Olores. That upon received of the information, PMF Villanueva relayed it to FPO Michael Rocha through mobile phone call after we proceeded to the said area to verify.

Upon on our arrival in the area, the team coordinated with the Barangay Captain Sabino Rojo in relation with the investigation. It is said that the complainant was Mr. Allan Antero Naranjo Jr. He complained that the previous tenant of Mrs. Minda Olores, who is Mr. Jimmy Opis, cut down the Gmelina Trees as a compensation for his effort in planting the said trees around the property without obtaining permission and legal documents to do so.

During the investigation, we found the tree stumps, two (2) abandoned round logs, and 10 pieces of lumber cut into various sizes: seven (7) pieces of 2"x 6" x 7", one (1) piece of 2"x 6"x 4" and two (2) pieces of 2"x 2"x7" with the total volume of 57.6 board feet. The stump, logs and lumbers were measured by BPA Ireneo P. Villanueva together with the team. The said forest products were hauled using the Barangay Service Vehicle (Chariot) and temporary placed at the Barangay Hall of Malibago under the Barangay's Custody for safekeeping.

Considering that the origin of the said forest product is within Alienable and Disposable land, it is by recommended that this case be referred to the Monitoring and Enforcement Section (MES) of the Technical Services Division for further investigation and appropriate action. Please find attached pictures, apprehension receipt and location map for references.
