## ANTECEDENT FACTS

The antecedent facts are based on relevant documents and testimonies gathered from the records of Naujan Municipal Police Station [Naujan MPS] and its officers, PSSg Jerlon B. Asinas and PCpl Jeffry M. Villeza [hereinafter referred to as "apprehending officers"], and Mr. Carlo S. Manalo [hereinafter referred to as "respondent"].

## Version of the Apprehending Officers

On 21 May 2022, PSSg Asinas and PCpl Villeza conducted intelligence monitoring at Barangay Pinagsabangan 2, Naujan, Oriental Mindoro. At around 12:30 in the afternoon, they've noticed an individual in the act of "sacking" wood charcoal who escaped immediately upon knowledge of their presence. In an attempt to arrest the said individual, they've encountered another person carrying two (2) chainsaws near a pile of chopped woods who was then identified to be the respondent in this proceeding, Mr. Manalo.

The apprehending officers introduced themselves as Naujan MPS personnel and asked for the respective certificates of registration of the chainsaws. For respondent's failure to present the required documents, the apprehending officers informed him that he will be arrested. He was also apprised of his rights under the law.

Correspondingly, an inventory of the chainsaws was done in the presence of the respondent and barangay officials, Freddie Naluz and Lynette Silang, with details, to wit:

One (1) piece blue/green Makita Chainsaw without serial number marked as "JMV-1" One (2) piece white/orange Sthil Chainsaw without serial number marked as "JMV-2"

Upon arrest of the respondent and inventory of the chainsaws, the apprehending officers immediately coordinated with DENR – CENRO Socorro.

On 23 May 2022, DENR – CENRO Socorro issued a <u>Certification that respondent has not registered or renewed any chainsaw from 2017 to date.</u> On the same day, the apprehending officers turned over the custody of chainsaws to the assigned DENR – CENRO Socorro personnel, Forest Rangers Arnaldo M. Pudiquet and Reymar R. Gunday.<sup>1</sup>

On 24 May 2022, the Office of the Provincial Prosecutor, issued a Resolution relative to NPS IV-07-INQ-22E-00099 finding probable cause for the violation of Section 7 (par.a) of Republic Act 9175 with an order that an Information be filed against the respondent. <sup>2</sup>

## Version of the Respondent

Contrary to the version of the apprehending officers, respondent Manalo narrated that he was having his lunch at a nipa hut or "kubo" located alongside the road when the officers arrived. The chainsaws were covered inside the nipa hut and the apprehending officers allegedly discovered such fact based on a tip they've received.

Respondent admitted that he owned the two (2) apprehended chainsaws and both were unregistered.<sup>3</sup>

## RECOMMENDATION

WHEREFORE, it is respectfully recommended that the seized (2) UNITS OF CHAINSAW (STIHL AND MAKITA) be confiscated in favor of the Government of the Philippines and such be disposed of in accordance with the existing laws and procedures.


