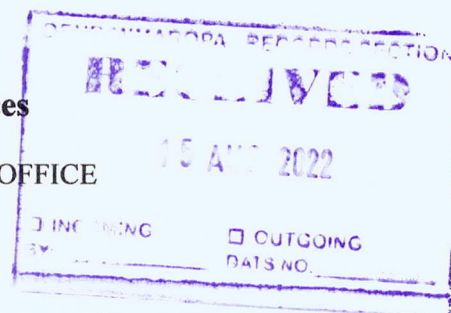

Respectfully forwarded is the memorandum of CENRO Coron, Palawan dated July 08, 2022 relative the above subject.

Per memorandum, the apprehension was made during the joint operation/LAWIN patrolling activities of CENRO Coron and BPRMO Personnel with the assistance of PNP Maritime Group, SOU Coron on January 28, 2022 at around 5:15 A.M. The team received a report that on-going hauling of lumbers at the time were being undertaken. Thereafter, apprehended fifty-eight (58) pieces lumbers of Baid, Lebey and Malwandit species with total volume of 281.40 board feet.

The said lumbers were apprehended at Sitio Kelyen, Barangay Decalachao, Coron, Palawan fair market value of the lumber is Php14,070.00. The apprehended item is now deposited at CENR Office for safekeeping purposes under the custody of Forest Technician II Elizalde M. Segundo.

Mr. Jonel Ebina, Mr. Ardie Lera and Mr. Sandrex Dadaya were caught in the act of hauling/carrying the said lumbers without permit or legal documents. Thus, the PNP Maritime had already filed a criminal complaint against the offenders for violation of Section 68 or 77 or PD 705, as amended with NPS Docket No. IV-08-INV-22B-0109.

The hearing was conducted on February 16, 2022 and the notices of hearing were sent to the concerned parties in relation to Section 8, Item No. 3 of DAO 1997-32. However, despite notices, the offenders did not appear to attend the Administrative Hearing.

We concur with CENRO recommendation for the issuance of confiscation order.

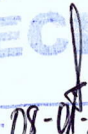

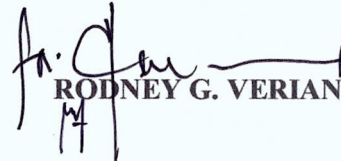
Despite of the three (3) letters of invitation that was sent to the offenders, they did not appear to attend the Administrative hearing.

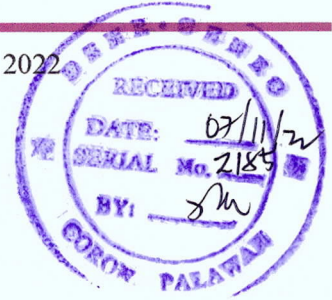

Respectfully submitted is the Administrative hearing report and other pertinent documents on the apprehended fifty eight (58) pieces lumber of Baid, Lebey and Malwandit species with a total volume of 281.4 bd. ft. at So. Kelyen, Brgy. Decalachao, Coron, Palawan on January 28, 2022.

Please be informed that during the conduct of Administrative hearing pursuant to DAO 97-32 held on February 16, 2022, Forest Technician II Elizalde M. Segundo narrated that a certain concerned citizen reported to him that hauling of lumber in So. Kelyen is being undertaken. Immediately he asked assistance from the Philippine Marines but there is no personnel available so he called the assistance of the PNP Maritime. Immediately upon briefing, they proceeded to the area and confirmed that there are stockpiled of lumber. About ten (10) meters away, they saw Jonel Ebina, Ardie Lera and Sandrex Dadaya. Apparently, they were hired to haul said lumbers but they did not revealed the name who hired them.

Despite of the three (3) letters of invitation that was sent to the offenders, they did not appear to attend the Administrative hearing.

The PNP-Maritime has already filed a criminal complaint against the offenders for violation of PD 705 Section 68, as amended with Docket No. NPS No. IV-08-INV--22B-0109.

Due to the above information, the undersigned hereby recommended for the issuance of "ORDER OF CONFISCATION" of the said 281.4 bd. ft. of different species in favor of the government pursuant to DAO 97-32 and other applicable laws, rules and regulation.
