**SUBJECT: CREATION OF THE PROTECTED AREA SUITABILITY ASSESSMENT (PASA) TEAM FOR EL NIDO-TAYTAY MANAGED RESOURCE PROTECTED AREA (ENTMRPA), EL NIDO, PALAWAN**

In the interest of the service and in order to determine the suitability/non-suitability or modification of boundaries of El Nido-Taytay Managed Resource Protected Area (ENTMRPA), El Nido-Taytay, Palawan as protected area, the creation of a composite team to conduct the Protected Area Suitability Assessment (PASA) of ENTMRPA is hereby authorized. The creation of PASA Team is pursuant to Section 5 of RA 7586 known as the National Integrated Protected Areas System Act (NIPAS Act of 1992) as amended by RA 11038 or the Expanded National Integrated Protected Areas System Act (ENIPAS Act of 2018) and its Implementing Rules and Regulations (DAO 2019-05).

- 1.) Facilitate the conduct of the rapid assessment, community consultations and other related activities in concerned areas within ENTMRPA in accordance with the relevant provisions of RA 11038 (ENIPAS Act of 2018), DAO 2019-05 (IRR of ENIPAS Act) and BMB Technical Bulletin No. 2016-04 “Clarifying the Procedural Guidelines in the Conduct of Protected Area Suitability Assessment (PASA);” and
- 2.) Submit progress and final reports as Means of Verification (MoV) of accomplishment to the Regional Office through the PENRO, guided by the provisions of BMB Technical Bulletin No. 2016-04 and other pertinent PA policies/guidelines.

All expenses to be incurred in this activity shall be charged against funds allocated for the PASA of ENTMRPA based on the approved ENTMRPA Integrated Protected Area Fund (IPAF) Work and Financial Plan, CY 2022.

This ORDER shall take effect immediately upon approval and automatically revoked upon completion of the activity with final report submitted to the Regional Office through proper channels.
