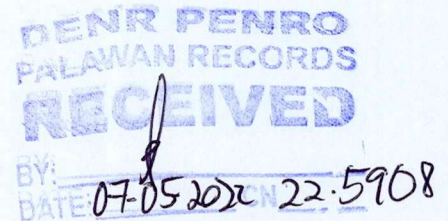

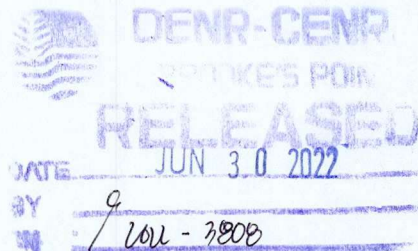

1. We can open the server and other LAMS computers but still cannot enter/ input new data of Public Land Applications in the system of Data Capture.
2. We cannot view in the system of Data Capture the scanned documents/files.
3. According to RO Jinky Sarong and previous LAMS data encoders, they were not trained in the system of LAMS PLA 4.4. /LAMS PLA 4.5

1. Designate personnel from PENRO or Regional Office that will address our problem in the system of LAMS Data Capture.
2. Request to conduct training on the system of LAMS PLA 4.4/ LAMS PLA 4.5
