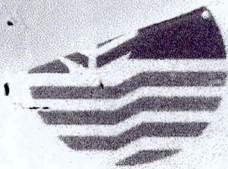

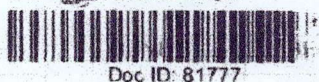

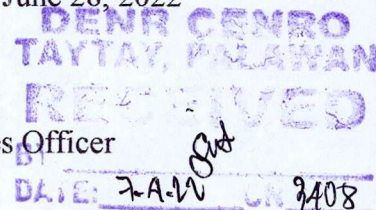

SUBJECT : **REPORT ON THE CONDUCTED CONTINUATION OF PROTECTED AREA SUITABILITY ASSESSMENT (PASA) FOR MALAMPAYA SOUND PROTECTED LANDSCAPE AND SEASCAPE (MSPLS) TAYTAY-SAN VICENTE**

This pertains to the target activity on the conducted Protected Area Suitability Assessment (PASA) under Protected Area Management and Development Sub-program of Malampaya Sound Protected Landscape and Seascape (MSPLS) Taytay-San Vicente, Palawan.

Please be informed that on January 21, 2022 to February 11, 2022, the Protected Area Management Office of MSPLS together with the PASA team facilitated the conduct of public consultation and on-site observations of the Protected Area Suitability Assessment (PASA) for MSPLS. The said activity was participated by selected barangay key officials, stakeholders within PA and representative from private sector. Selection of key informants was based on the BMB Technical Buletin No. 2016-04. A total of 231 males and 202 female attended in the activity. The activity was graced by a prayer followed by a welcome message of representative from each barangays..

During the said activity, PASu Clarissa P. Pador presented the rationale of the activity. Afterwards, CDS Chief Carolyn A. Esmenda presented the proposed modified boundary in the PA highlighting the build-up areas of the barangays that falls within the protected area including land classification of forestland/timberland, alienable & disposable and unclassified public forest. She also presented the result of the discussion during community meeting last year and the recommendation of the Regional Executive Director during the presentation of the result of conducted PASA and Spatial Analysis workshop of PASA Team. Among the issues raised by the stakeholders presented during the open forum were as follows.

Barangay Poblacion

1. The stakeholders manifested that only the upper part of the cultivated identified areas to be excluded. The areas in Arado I, II and Sitio Igang should be included in the Protected Area. The rest of the area should be excluded because areas in the town proper are highly developed.
2. The identified areas to be excluded in the Protected Area should be under the management of the Local Government Unit (LGU).

Barangay Pamantolon

1. The stakeholders suggested clarifying their area if it is within A&D or timberland in order for them to decide whether to include or exclude parts of their barangay in the protected area because there are communities in the lower part of the area.
2. Their decision will be included in the position paper to be submitted before end of the month.



Barangay Alacalian

1. They are anxious of losing their claims over their occupied lands once the classification becomes national park.
2. They inquired on the establishment (school buildings, etc) that already build within the developed areas, but still the classification is timberland/forestland before the protected area was declared.
3. The stakeholders recommended for the conduct of joint community meeting of the DENR and BLGU before coming up with recommendations/position papers.

Barangay Talog

1. Suggested to exclude the A&D area of Talog in the protected area and to reclassify portion of timberland that are develop and with improvements within the protected area.
2. They are anxious losing of their claims over their occupied lands especially those in the agricultural area.

Barangay Calawag

1. Portion of the area shall remain in the PA. They also appealed to conduct patrolling within the area to monitor the illegal cutting of trees.

Barangay Abongan

1. The stakeholders proposed to exclude the A&D and other areas because since 1960 they occupied and developed the area within the PA, while the other areas of A&D will be included in the buffer zone.
2. Proposed to reclassify portion of timberland that are develop and with improvements within the protected area.
3. The stakeholders committed that they will submit position paper and will conduct consultation/s with their constituents.

Barangay Bato

1. Proposed to exclude the A&D within PA, but there should be a buffer zone in every river/watershed.
2. Stakeholders were anxious of losing their claims over their occupied lands once the land classification becomes national park considering that the land titling is prohibited.
3. The stakeholders were concerned about the provisions of a protected area in their agricultural activities once the land classification becomes national park.

Barangay Paglaum

1. They are concerned about those areas classified as timberland that are already cultivated/ improved and requested to have a reclassification on the mentioned areas.
2. They were asking the policy/guidelines in terms on the proper uses of insecticides since their area is within the protected area.
3. The stakeholders proposed to exclude the A&D area within Protected Area.
4. Anxious of losing their claim over their occupied land once the land classification becomes national park.

Barangay Libertad

1. The stakeholders proposed to exclude the A&D area within Protected Area since the area is fully developed.

Barangay Pancol

1. They are requesting to reflect the CBFM area in the map of Bgy. Pancol.
2. There is an IP group in Bgy. Pancol and they are requesting to consider their rights on their ancestral domain inside the PA since the source of their income and livelihood activity is within the area.

Barangay Cataban

1. Anxious of losing their claim over their occupied land once the land classification becomes national park.
2. They do not know the area of A&D and timberland within their jurisdiction for them to restrict those contractors in the extraction of sand and gravel in Cataban River.

Barangay Liminangcong

1. The BLGU is planning to construct MRF and barangay cemetery, but there is no specific area for the project due to conflict of land status.
2. The issues on the land classification (timberland) of their barangay, since the area was already fully developed. Anxious of possible relocation site since their area was still in the PA and its land status is timberland.
3. The BLGU, stakeholders and People Organization committed to submit their recommendations/position papers after the session of the barangay council.
4. They manifested that community in the area should be considered in boundary modification since they are in the area long time ago prior to the proclamation of PA and continuously developed and improved the area.
5. They were asking for the legal basis about which area can be excluded or included in the Protected Area.

Barangay Tumbod

1. The stakeholders requested to consider the community in the easement area of Barangay Tumbod.

Barangay New Guinlo

1. They inquired about the possible advantages and disadvantages of being inside the Protected Area.
2. They inquired about their status since their application was already in the process for titling.
3. The stakeholders committed that they will submit position paper and will conduct consultation/s with their constituents.

Barangay Old Guinlo

1. The issues on land ownership especially those in the A&D long time ago before the area was declared as protected area.
2. They inquired if there are changes or amendment in prohibited act within the protected area including the Water Code of the Philippines if they will submit the issues to the congress.
3. Anxious of losing their settlement if the policy on water code of the Philippines (easement zones) will be implemented.



4. They manifested to exclude the built-up/developed areas within the PA.

Barangay Minapla

1. They inquired the process on how to reclassify land status.
2. They inquired their status as tenured migrants since they are not included in the list.
3. The stakeholders committed that they will submit position paper and will conduct consultation/s with their constituents
4. The beach of Bgy. Minapla is marine turtle nesting site thus be considered part of the PA.

Barangay San Jose

1. Some of the residents were affected by typhoon "Ondette" and wanted to rebuild their house, but there is no specific relocation site within the area.
2. The barangay council has a budget for the proposed relocation site, but they do not know the exact site of the project since the barangay is classified as timberland.
3. They inquired the possible arrangement to those names not included in the list of tenured migrants, but they are in the area before the protected area was declared.
4. The BLGU recommended to conduct consultation meeting to their constituent before coming up with recommendations/position papers.

Barangay Banbanan


1. Stakeholders asked about the advantages and disadvantages of being in the protected area.
2. There are resident holding a foreign titled.
3. Anxious of losing their claim/house once the 40 meters easement zone will be implemented.
4. Majority of the stakeholder's attended during the meeting agreed to be included in the protected area.
5. The BLGU recommended conducting consultation meeting to their constituent before coming up with recommendations/position papers.

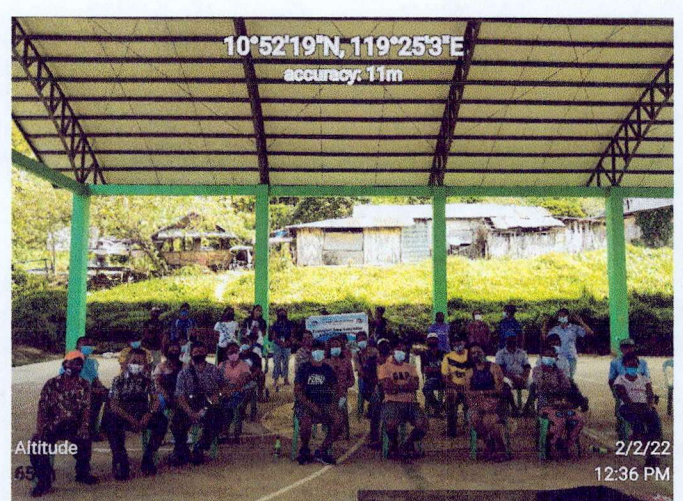



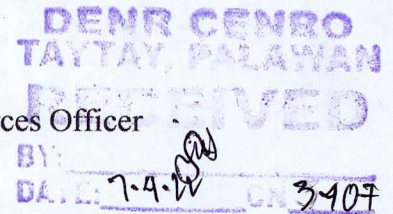

This pertains to the target activity on the conducted Protected Area Suitability Assessment (PASA) under Protected Area Management and Development Sub-program of Malampaya Sound Protected Landscape and Seascape (MSPLS) Taytay-San Vicente, Palawan.

Please be informed that on February 15, 2022 to February 17, 2022, the Protected Area Management Office of MSPLS together with the PASA team facilitated the conduct of public consultation and on-site observations of the Protected Area Suitability Assessment (PASA for MSPLS) held at Covered Court of Barangays Binga, New Canipo, Sto. Niño and Alimanguan, San Vicente, Palawan. The said activity was participated by selected barangay key officials, stakeholders within PA and representative from private sector. A total of 60 male and 51 female participants attended during the activity. The activity was graced by a prayer followed by a welcome message of representative from each barangays. During the said activity, PASu Clarissa P. Pador presented the rationale of the activity.

Afterwards, CDS Chief Carolyn A. Esmenda presented the proposed modified boundary in the PA highlighting the build-up areas of the barangays that falls within the protected area including land classification of forestland/timberland, alienable & disposable and unclassified public forest. She also presented the result of the discussion during community meeting last year and the recommendation of the Regional Executive Director during the presentation of the result of conducted PASA and Spatial Analysis Workshop of PASA Team. Among the issues raised by the stakeholders presented during the open forum were as follows.

Barangay New Canipo

1. The stakeholders recommended to exclude within MSPLS the agricultural areas, tourist spot and Isla Canipo. The rest of barangay will remain to the PA.
2. The beach of Bgy. Sto. Niño is known as nesting site of marine turtle.

Barangay Binga

1. The BLGU recommends to exclude the tourist destination and agricultural areas within protected area and rest of the barangay will remain to the PA.
2. They requested to remove the TIEZA map in the jurisdiction of the barangay.


Barangay Sto. Niño

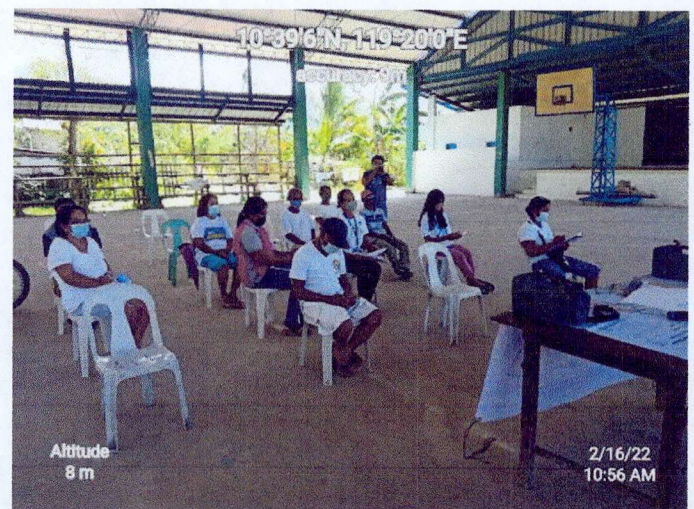


