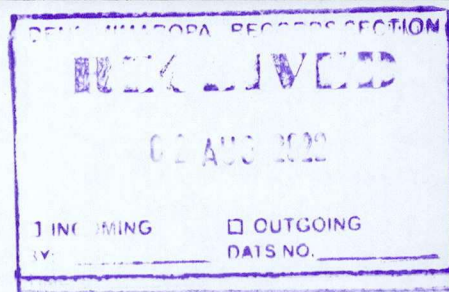

Requesting further is the transmittal of the complete record leading to the execution of the Decision dated May 10, 2019.



This pertains to the letter of intent dated June 2, 2022 of Antonio G. Goh requesting to file for an appropriate public land application over a parcel of land identified as Lot No. 6834, Cad. 799-D located in Bgy. Iraan, Aborlan, Palawan.

Per verification from the records of this Office, it shows that Lot No. 6834, Cad. 799-D containing an area of 88,356 square meters located in Bgy. Iraan, Aborlan, Palawan is listed in the name of Mario Tirco and covered by HA (IV-27) 869 of Stephen Ora which was filed on September 15, 1985.

Furthermore, Lot No. 6834, Cad. 799-D along with Lot No. 6827, Cad. 799-D were covered by DENR Case No. M-1-19-L entitled "Antonio Goh versus FPA (IV-27) 461 of Angel Ora and FPA (IV-27) 869 of Stephen Ora substituted by Jose Ma C. Tugas, Sr." which case was already covered by a Decision dated May 10, 2019 issued by then RED Henry A. Adornado wherein the dispositive portion of which is hereunder quoted:

*"WHEREFORE, premises considered, AFTER the lifting of the Memorandum dated May 28, 2015 of the Undersecretary for Field Operations, the PENR Officer/CENR Officer concerned is hereby directed to:*

- 1. GIVE DUE COURSE to FPA (IV-27) 461 of Angel Ora over Lot No. 6827, Cad. 799-D;*
- 2. REJECT FPA (IV-27) 869 of Stephen Ora over Lot No. 6834, Cad. 799-D; and*
- 3. Protestant Antonio Goh is DIRECTED TO FILE the appropriate public land application over Lot No. 6834, Cad. 799-D."*



Moreover, the subject case was covered with a Resolution dated November 17, 2020 issued by the RED Maria Lourdes G. Ferrer where portion of which is hereunder quoted:

*"Perusal of the Motion shows that the issues raised therein do not make out a new matter sufficiently persuasive to induce modification of judgment. As such, we find no ground or cogent reason to disturb and/or modify the Decision dated May 10, 2019."*

Please be informed that Section 20 of DENR Administrative Order (DAO) No. 2016-31 provides that:

*"Any of the parties may file a Motion for Reconsideration (MR) of the Decision of the RD within fifteen (15) days from the receipt thereof. Only one MR shall be allowed. The RD shall have fifteen days (15) days to act on the MR."*

*If no MR is filed, or filed outside the reglementary period, the Decision of the RD shall become final and executory. xxx-xxx*

Further, Section 22 of DAO No. 2016-31 provides that:

*"Any aggrieved party may take an appeal to the Office of the Secretary by filing a notice of appeal and paying the appeal fee to the Office of the RD within fifteen (15) days from receipt of the Order or Resolution/Decision of the case. The appeal shall be perfected after filing of the notice of appeal and payment of appeal fee within the prescribed period. xxx-xxx*

In this regard, may we respectfully request for a Certification whether a Motion for Reconsideration or Notice of Appeal was filed by the aggrieved parties, to be issued by the Records Officer of that Office and the return of the original case records to this Office for its execution and further action.
