ORIENTATION ON MENTAL HEALTH AWARENESS

Pursuant to R.A. 11036 which is also known as the "Mental Health Act" with aims to enhance the delivery of integrated mental health services, promote and protect the rights of persons utilizing psychiatric, neurologic and psychosocial health services, appropriating funds, therefore, and for other purposes.

In relation to the above-stated purpose, the Human Resource Development Service-Training and Development Division conducted the Orientation on Mental Health Awareness for all DENR officials and employees nationwide on August 11, 2022 from 1:00 PM to 4 PM via zoom platform.

A total of eighteen (18) PENRO personnel attended the said orientation at PENRO Training Hall, Bgy. Sta. Monica, Puerto Princesa City wherein twelve (12) are female and six (6) are male.

During the said orientation, Dr. Renz Christian Argao, RPm and Marc Angelo Ronquillo, MA (cand), RPm were the lecturers. They have discussed the six (6) Training Plans that are significant to be undertaken by the employees in order to cope with mental stress, take care of their mental health and when to request professional help. The employees stated that different stressors at work affect their mental health and the Registered Psychometricians have recommended the participants on what are the necessary steps to be taken to achieve good mental health at work.

Along this line, it is also been noted and advised by the speakers to avoid toxic people at work, learn to say "no" to people that drain or overwhelm your energy, and avoid unhealthy conversations that also decrease the productivity and efficiency of employees at work, be with good people and such other tips that are significant to be undergone by the employees for their emotional care, social care, physical care and spiritual care. Likewise, it is also advised to have a self-care plan, and implement and evaluate the coping strategies that are beneficial for the employee's mental health.
