# AN EXECUTIVE ORDER RECONSTITUTING PEACE AND ORDER PROGRAM AND THE LAW **ENFORCEMENT TASK FORCE**

WHEREAS, the Local Government Code of 1991 provides that local government units shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare (Section 16, Republic Act 7160)

WHEREAS, the same Code bestows upon the Governor the authority to issue executive orders for faithful and appropriate enforcement and execution of laws and ordinances (Section 465, RA 7160);

WHEREAS, the Governor may issue executive orders which shall be used as guidelines in implementing a specific program as provided for in the Local Government Code of 1991. Executive Orders are acts of the Local chief executive providing for rules of a general or permanent character in implementation or execution of a constitutional or statutory provision;

WHEREAS, there is an existing Executive Order entitled "Creating a Law Enforcement Task Force under the Peace and Order Program;

WHEREAS, there is a need to amend the said Executive Order to offer clearer and more responsive secretariat that will provide for its duties and functions;

NOW THEREFORE, I, V. DENNIS M. SOCRATES, Governor, Province of Palawan, by virtue of the powers vested in me by law, do hereby ORDER:

SECTION 1. RECONSTITUTION. The LAW ENFORCEMENT TASK FORCE is hereby reconstituted under the direct supervision of the Office of the Governor.

SECTION 2. COMPOSITION. The Task Force shall be composed of the following:

**SECTION 3. FUNCTION OF THE LAW ENFORCEMENT TASK FORCE.** The Law Enforcement Task Force shall coordinate and/or supervise all efforts of law enforcement agencies and prosecution of offenses related to the following:

- 1. Protection of the environment;
- 2. Trafficking of drugs;
- 3. Trafficking in persons;
- 4. Trafficking of unlicensed firearms;
- 5. Counter-terrorism and Insurgency; and
- 6. Any other related offenses.

**SECTION 4. FUNDING.** Funding shall be from the Peace and Order Fund under the Office of the Governor.

SECTION 5. THE PEACE AND ORDER PROGRAM. It shall be headed by the following:

1. Director. PCOL Gabriel C. Lopez (Ret) is hereby appointed as the Program Director of the Peace and Order Program with the following duties and functions:

a. Formulate policies, guidelines, and programs to effectively carry out the purposes of Peace and Order Program;

- b. Direct, control, and supervise the administration and operations of the POP:
- c. Promulgate rules as may be necessary or proper for the effective exercise of the powers and functions of the Law Enforcement Task



- Force: POP, as well as the discharge of the duties and responsibilities of its personnel;
- d. Deploy any of its personnel for missions when it calls for the protection and security of the province;
- e. Designate POP agents for investigation purposes;
- f. Remove, suspend, or otherwise discipline POP personnel for cause in accordance with Civil Service Rules and Regulations and other pertinent laws;
- g. Perform any and all acts necessary, proper or incidental to the attainment of the purposes and objectives of the POP;
- h. Perform such other functions as may be provided by law or authorized by the Law Enforcement Task Force;
- i. Sign official documents in relation to POP such as Financial Plans, List for Hires, Contracts, OBR's, and other papers related thereto;
- j. Initiate and conduct intelligence operations and projects;
- k. Accountable for making disbursements of Confidential Fund and/or Intelligence Fund;
- Responsible for the liquidation of Cash Advance for Confidential Fund/ and or Intelligence Fund;
- m. Supervise the conduct of intelligence, operations and investigations activities of the POP;
- n. Formulate policies on intelligence operations and investigations of the POP;
- o. Submit periodic reports; and
- p. Perform such other functions as may be required.
- 2. Deputy Director for Administrations, Finance and Operations. Zharra S. Acosta Security Officer IV is hereby designated as the Deputy Director for Administration Finance and Operations of the Peace and Order Program with the following duties and functions:
  - a. Coordinate, review and make recommendations regarding POP's personnel matters; including recruitment, hiring, discipline, investigations, personnel actions and workers compensation;
  - Oversee and participate in the POP's finance and operations including the development and administration of the annual budget and the forecasting of funds needed for staffing, equipment, materials and supplies; monitor and approve expenditures; implement adjustments;
  - c. Assume management responsibility for assigned services and activities of the Law Enforcement Task Force: POP including budget, human resources, purchasing, safety, worker's compensation, records and services;
  - d. Manage, supervise and assume program responsibility for the Director function;
  - e. Coordinate with other related office in relation to personnel and budget activities;
  - f. Manage and participate in the development and implementation of goals, objectives, policies and priorities for the POP: conduct a variety of organizational studies, investigations and operational studies; recommend modifications to existing office programs, policies, and procedures as appropriate
  - g. Monitor the conduct of intelligence, operations and investigations activities of the POP;
  - h. Execute policies on intelligence operations and investigations of the POP;
  - i. Develop and maintain POP database including evidence data;

- j. Monitor all cases related to POP
- k. Recommend measurers for the collaboration of law enforcement agencies to enhance the operations;
- Coordinate with other agencies on matters to address peace and order matters;
- m. Facilitate specialized training and seminars;
- n. Review documents in relation to POP such as Financial Plans, List for Hires, Contracts, OBRs, and other papers related thereto in the absence of the Director.
- o. Perform other tasks as directed.

**SECTION 6. REPEALING CLAUSE.** All other existing orders, memoranda all issuances in conflict herewith are hereby deemed revoked and/or modified accordingly.

SECTION 7. EFFECTIVITY. This Order shall take effect immediately.
