

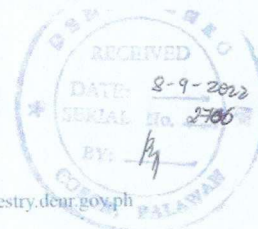

This pertains to the email received by the CENR Office on August 5, 2022 from the DENR PENRO Palawan regarding the forwarded above matter to the PENR Officer from the DENR Action Center.

On the undated letter of Mr. Demetrio G. Wagwag, for the Office of the President, Presidential Action Center received on June 22, 2022 is requesting for the General Verification and Issuance of Special Order (RSO) to deal with land conflict in So. Benecan, Brgy. San Nicolas, Coron Palawan. The letter was also attached with a response letter dated May 4, 2022 from the DENR, CENR Officer Coron address to Ms. Gina Labajo pertaining to her request for general verification survey on a parcel of land situated at So. Benecan, Brgy. San Nicolas, Coron Palawan. The following findings of the team conducted the verification are as follows;

1. During the conducted investigation/verification it was found out the subject area requested by Agri-Farmer, Fisher Folks Association Incorporated headed by Mrs. Labajo for general survey is within the jurisdiction of the BPR (Please refer to the map attached);
2. On the issue of emergence of titles lot on the area with TCT# 6498 records shows that same concern were brought to this office, a separate investigation was already conducted on the matter with reference to the memorandum report dated June 01, 2022 (Please see attached memorandum report);
3. Regarding occupation in the area, records of this Office shows that only 19 personalities was found occupying the area based on the conducted profiling activity conducted by the BPRMO and CENR Office on 2016 to 2017;

4. Lastly, on matter of National Legal Process of Appeal of Federation Puerto Princesa City (NALEPAF) based from records of the CENRO in reference to the memorandum dated February 24, 2020 of the OIC-PENRO, Palawan for the Regional Executive Director of DENR-MIMAROPA, NALEPAF is declared a nuisance group and therefore all communication from Mr. Wagwag and company be no longer entertained.
