



This refers to a parcel of land identified as Lot 2 F (IV-13) 1447-D located in Bgy. Tiniguiban, Puerto Princesa City containing an area of 8,824 square meters. The application for free patent in the name of PRISCILLA MIGUEL-SEBIDO, my grandmother, was approved in 1975. A copy is attached for your reference.

We also have a Certification issued by the DENR-CENRO stating that this property is classified as alienable and disposable land. A copy is attached for your reference. This property is also tax-declared in name of CORNELIO MIGUEL, father of PRISCILLA wherein this property is classified as residential land. A copy is also attached for your reference.

The City Government interposed an objection to the issuance of the title claiming that they intend to use the property as a public road. In Resolution No. 1484-2021 dated December 20, 2021, the City Government forwarded this matter to the DENR-MIMAROPA Regional Office for Resolution. A copy of the Resolution is attached for your reference.

On two (2) occasions, the DENR CENRO conducted an ocular inspection of the property but did not issue the result of its inspection. The fact of the investigation is stated in the letter by OIC-CENRO dated September 2, 2019, a copy is also attached for your reference.

This property is no longer available as a road because portions of this property beside the North National Highway have already been issued titles through Miscellaneous Sales Applica-tions. These persons are not even heirs of CORNELIO MIGUEL or PRISCILLA MIGUEL-SEBIDO. Their titles were issued also by virtue of City Resolution. A copy of the resolution is attached for your reference.



RESOLUTION NO. 1484-2021

Sponsored by: Committee on Legal Matters

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) MIMAROPA REGIONAL OFFICE TO EXPEDITE ITS RESOLUTION PERTAINING TO THE PROPERTY KNOWN AS LOT 2 F (IV-13) 1447-D LOCATED AT BARANGAY TINIGUIBAN, THIS CITY.

WHEREAS, Article II, Section 10 of the 1987 Philippine Constitution declares, that: "It the policy of the State to promote social justice in all phases of national development";

WHEREAS, Article XII, Section 6 of the aforesaid Constitution provides, that: "The use of property bears a social function, and all economic agents shall contribute to the common good. Individuals and private groups, including corporations, cooperatives, and similar collective organizations, shall have the right to own, establish, and operate economic enterprises, subject to the duty of the State to promote distributive justice and to intervene when the common good so demands;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", provides, that: "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, pursuant to Executive Order No. 192, Series of 1987, the Department of Environment and Natural Resources is mandated as the primary agency responsible for the conservation, management, development, and proper use of the country's environment and natural resources, specifically forest and grazing lands, mineral resources, including those in reservation and watershed areas, and lands of the public domain, as well as the licensing and regulation of all natural resources as may be provided by law in order to ensure equitable sharing of the benefits derived therefrom for the welfare of the present and future generations of Filipinos;

WHEREAS, Section 5 (m) of the aforesaid Executive Order provides, that: "To accomplish the said mandate, the DENR shall have the power and function to exercise exclusive jurisdiction on the management and disposition of all lands of the public domain and shall continue to be the sole agency responsible for classification, sub-classification, surveying and titling of lands in consultation with appropriate agencies";

WHEREAS, this August Body is in a receipt of a letter from Ms. Lucybeth H. Ladrillo, et al., requesting for the intervention of the members of the City Council pertaining to the property which is a portion of Lot 2- F (IV-13) 1447-D located at Barangay Tiniguiban, this City;

WHEREAS, as Heirs of Priscilla Miguel Sebido, Ms. Lucybeth H. Ibañez, together with her siblings, applied for a Residential Free Patent with the DENR-CENRO, Puerto Princesa City, over the land known as Lot 2 F (IV-13) 1447-D situated in Barangay Tiniguiban, this City, containing an area of 8,824 Square Meters, more or less;

WHEREAS, on May 3, 2012, the City Government of Puerto Princesa, through the Office of the City Planning and Development Coordinator, interposed its objection on the said Residential Free Patent Application of Ms. Lucybeth H. Ibañez by way of an endorsement letter forwarded to the DENR-CENRO, Puerto Princesa City, with the information that the subject area is a part of a Distributor/Collector road between the North and South National Highway and that an appropriation has already been made for its opening and concreting under 2012 Annual Investment Program of the City Government of Puerto Princesa;

WHEREAS, this subject matter was referred to the Committee on Legal Matters during the 115th Regular Session of the Sangguniang Panlungsod of Puerto Princesa and deliberated the same;

WHEREAS, during the 119th Regular Session of the Sangguniang Panlungsod of Puerto Princesa City, Hon. Nesario G. Awat, Chairman of the Committee on Legal Matters, reported out that during its committee meeting, Ms. Eliza Aborot, representative of DENR-CENRO, Puerto Princesa, informed the committee that the said subject matter between the Heirs of Priscilla Miguel-Sebido and the City Government of Puerto Princesa pertaining to Lot 2 F (IV-13) 1447-D was already forwarded to the DENR MIMAROPA Regional Office for its resolution;

WHEREAS, this August Body, considering that this subject matter was already forwarded to the DENR MIMAROPA Regional Office for its resolution, finds it appropriate to earnestly request the DENR MIMAROPA Regional Office to expedite its resolution pertaining to Lot 2 F (IV-13) 1447-D located at Barangay Tiniguiban, this City, containing an area of 8,824 Square Meters, more or less.

NOW THEREFORE, on motion of Hon. Victor S. Oliveros, City Councilor, Majority Floor Leader,
