Respectfully forwarded is the memorandum dated August 09, 2022 from CENRO Puerto Princesa relative the above subject.

Based on the report, on August 04, 2022 at around 4:30 in the afternoon, the MES personnel, PNP Anilawan personnel, Intelligence Unit of Puerto Princesa City Police Office and Bantay Gubat Anilawan conducted apprehension in response to the intelligence report received. The team apprehended one (1) unit of STIHL Chainsaw with Engine No. 122019720/PCSD Metal Seal No. 1573 and (34 pieces *(in the report)* / 30 pieces *(in the scale sheet)* lumbers of Dao species with equivalent volume of 414 board feet.

The apprehended items were in the possession/custody of Fely Boy A. Dumlao (Chainsaw Operator), Roel F. Ogalisco (Helper) and the identified Chainsaw Owner is Nieves P. Abrea. Upon investigation, the perpetrators failed to present permits/legal documents which is in gross violation of Section 77 of PD 705, as amended and RA 9175 or the Chainsaw act of 2002.

The subject chainsaw and the lumbers were brought to Anilawan DENR Forest Products Monitoring Station for temporary safekeeping under the custody of Forest Ranger Raymond Sapalo.

CENRO Puerto Princesa is now facilitating the conduct of administrative hearing pursuant to DAO 1997-32 and gathering of affidavits and other related legal documentations for filing of appropriate case/s before the proper court.

1. **WHAT:** Violation of Sec.77 of PD 705 as amended "Possession of lumber without permit or legal documents", and Sec. 7 (4) of RA 9175
2. **WHO:** Fely Boy A. Dumlao and Roel F. Ogalisco
3. **WHEN:** August 04 more or less 4:30 PM
4. **WHERE:** So. Tarabidan, Bgy. Tanabag, Puerto Princesa City
5. **HOW:** The MES personnel composed of the undersigned, FR Reymund Sapalo, FR Michael Polido, FPO Edwin Guilaran, FPO Argie Porka and FPO Robert Abrea together with PNP Anilawan, PCPL Richard Temple and PCMS Sunny Miranda of City Intelligence Unit of PPCPO and Bantay Gubat Anilawan, conducted an apprehension of 34 pcs Dao lumbers with total volume of 414 Bd.ft and one unit chainsaw under the possession/custody of Mr. Fely Boy A. Dumlao and Roel F. Ogalisco.

The suspects were caught in the act of slicing Dao logs using a chainsaw which later found to be registered to Ms. Nieves Abrea, within a timber land area. Upon investigation, they failed to present permit to cut/sliced Dao which is a naturally growing tree species and is strictly prohibited to be cut/sliced without a valid permit, hence such act tantamount to a violation of Sec. 77 of PD 705.


During apprehension the perpetrators failed to bring with them the chainsaw registration which is required, per existing laws, to accompany the unit during its operation or actual use. Per Certificate of Registration number AM-PPC-2022-163, which later presented to us by Punong Barangay Marcelito Dancil of Tanabag, the chainsaw was registered to Ms. Nieves Abrea with limitation of use to titled property only and therefore the operation of the suspects within the timberland area is a violation of Sec. 7 paragraph 4 of the RA 9175.

Due to the above-mentioned violations, the composite team apprehended the forest products and the chainsaw and brought to Anilawan DENR forest products Monitoring Station for legal custody.

In view of the foregoing, the undersigned recommends that an administrative adjudication be conducted pursuant to DAO 97-32 and filing of criminal complaints of the evidence so warrant.
