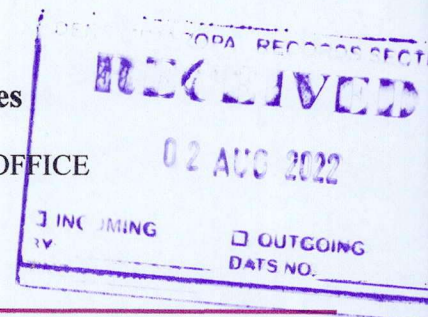

Respectfully forwarded is the memorandum of CENRO Quezon, Palawan dated June 14, 2022 relative the above subject.


Per memorandum, the apprehension was made on May 17, 2022 at around 4:20 P.M. by the Monitoring and Enforcement Section of CENRO Quezon at Barangay Campung Ulay, Rizal, Palawan. The team conducting monitoring and patrolling activities and apprehended the stockpiled lumbers that left unattended at the vacant lot area of the said barangay and no one claims for its ownership. The apprehended lumbers were seven (7) pieces (145.83 board feet) of Ipil species with estimated fair market value of lumber is Php7,291.50.

The subject lumbers were brought to DENR CENRO Quezon-Rizal Station located at Barangay Punta Baja, Rizal, Palawan under the custody of ECOMS II Michael V. Joven for safekeeping.


Notices to the public dated May 30, 2022, June 09, 2022 and June 24, 2022 were posted on three (3) different conspicuous places in the municipality of Rizal, Palawan in relation to Section 8, Item No. 3 of DAO 1997-32. However, no one appeared and claimed in the Office. Hence, the absence of the owner/claimants to appear shall be deemed a waiver of their rights to the items apprehended in favor of the government.

Therefore, we concur with the CENRO recommendation for the issuance of confiscation order and order of finality of the forest product in favor of the government.

Submitted herewith is the summary of the Administrative Confiscation Proceedings together with pertinent documents anent the above-cited subject treated under DAO 97-32.

I. FACTS OF CASE

WHAT : Apprehension of Seven (7) pieces of Ipil lumbers having a total volume of 145.83 board feet with an estimated fair market value of Php 7,291.50.

WHEN : At around 4:20 PM of May 17, 2022

WHO : No claimant/Abandoned

WHERE : Brgy. Campung-Ulay, Rizal, Palawan

HOW : At around 4:20 PM of May 17, 2022, the team of Monitoring and Enforcement Section while patrolling at Barangay Campung-Ulay, had apprehended 7 pieces of Ipil lumbers having a total volume of 145.83 board feet. Per on-site investigation, no person/claimant found in the area, hence, declared abandoned. The apprehended lumbers were brought to DENR-CENRO Quezon, Rizal Station compound, Rizal, Palawan for safekeeping under the custody of ECOMS II Michael V. Joven. Subsequently, a Seizure Receipt and Seizure Order dated June 01, 2022 were issued by the undersigned.

II. NOTICE TO THE PUBLIC FOR THE CONDUCT OF HEARING:

Pursuant to the provisions of Department Administrative Order No. 97-32 Re: Rules for Administrative Adjudication of Illegal Forest Product and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 08, item No. 03, posting of notice to the public for the conduct of administrative hearing for three (3) consecutive weeks at the different conspicuous place of Rizal, Palawan was conducted by this Office.

III. FINDINGS/EVALUATION:

In spite of the three (3) consecutive notices posted however, no claimant appeared before this Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their right to the items apprehended in favor of the government.


IV. APPLICABLE LAWS:

Department Administrative Order No. 97-32 Section 8, item no. 3, Notice of Hearing shall be posted at least three (3) times, once every week for three (3) consecutive weeks, in at least three (3) public places, including, but not limited to: (a) the Barangay Hall of the apprehension site; (b) the Bulletin Board of the DENR Offices where the Proceedings will be conducted, and (c) at the Municipal Hall of the apprehension site.

V. RECOMMENDATION

In view hereof, it is recommended that the Seven (7) pieces of Ipil lumbers having total volume of 145.83 board feet with an estimated market value of Php 7,291.50 apprehended at Brgy. Campung-Ulay, Rizal, Palawan be confiscated in favor of the government.
