HUNDRED (300) SACKS OF WOOD CHARCOAL AT BARANGAY SAN ROQUE, BULALACAO, ORIENTAL

MINDORO

Please be informed that on July 19, 2022, a red wing van truck bearing plate no. 1801-00000099687 traversed from Bulalacao going to Calapan City. The driver of the said vehicle lost control and veered its direction towards the right shoulder resulting to bump a big tree along side of the road at Barangay San Roque, Bulalacao, Oriental Mindoro.

Based on the submitted report and initial investigation conducted by MPS Bulalacao, said conveyance was loaded with wood charcoal to be delivered to Calapan City. The driver failed to present the legal document to warrant its legality.

However, when the driver was arrested and was inside the police precinct, he showed to the MPS Bulalacao an electronic copy of the Certificate of Transport Agreement (CTA) which was forwarded to him by unknown personality. Further, the driver is using a fake permit which was signed by Forester Raymond F. Paredes who was retired/separated in the government service since September 18, 2019.

INCIDENT REPORT ON THE APPREHENDED THREE

HUNDRED (300) SACKS OF WOOD CHARCOAL AT BRGY. SAN

ROQUE, BULALACAO ORIENTAL MINDORO

On July 19, 2022, the Monitoring and Enforcement Section (MES) received a report from the MPS-Bulalacao regarding an incident at Brgy. San Roque, Bulalacao, Oriental Mindoro.

According to the Spot Report of MPS-Bulalacao, on July 19, 2022 at about 2:10 am, there was an accident that transpired at Brgy. San Roque, Bulalacao, Oriental Mindoro. The Wing Van truck driven by Erin Sadiasa was traversing the National Highway going to Calapan when Erin lost control of the vehicle and veered its direction towards the right shoulder of the road and bumped into the big tree along the side of the road that caused the instantaneous death of Jericho E. Nobelo, companion of the driver.

Upon initial investigation, the Wing Van Truck was loaded with 300 hundred sacks of wood charcoal. The driver failed to present any document or permit when asked for the legality of its transport. He was then arrested.

During the coordination of personnel of CENRO-Roxas with MPS-Bulalacao, Police Major Honorato A. Balinte showed a picture of Certificate of Transport Agreement (CTA) to them. According to him, when driver was inside the precinct, the driver showed him through his phone the said CTA. The driver disclosed that the CTA was given by unknown person to him together with the 300 sacks of wood charcoal. He will only have to pick-up and load the wood charcoal and everything is settled.

Police Major Honorato A. Balinte, then verified with CENRO-Roxas the authenticity of CTA since the signatory indicated for the CENRO is Raymond E. Paredes and not the undersigned.

The initial investigation revealed that the driver is using a fake permit.

1. What: Spot Report on RIR to Homicide and Violation of PD 705 (Illegal Transport of Forest Product Wood Charcoal)


2. Where: Brgy. San Roque, Bulalacao, Oriental Mindoro.

3. When: July 19, 2022 at about 2:00 AM.

4. Who: The suspect was identified as Erin Sadiasa Cabinbin, 37 years old, single, resident of Batasan Quezon City, driver of Wing Van Truck, color red with plate no.99687 registered to Nilo Siddayao and a resident of L17B5 Loremar HMS, Motero Antipolo City while the victim was identified as Jericho E Novelo, 22 years old, single, helper and a resident of Cagayan Vally.

5. How/Why: That on July 19, 2022 at about 2:10 AM, a concerned citizen called to Bulalacao MPS and informed about a traffic accident that transpired at the said place. Immediately thereafter, elements of this office proceeded to the area to verify the veracity of the report and to conduct investigation thereat. Investigation disclosed that said vehicle was traversing from Bulalacao going to Calapan City, upon reaching the place on incident the driver lost control of his driving vehicle and veered its direction towards the right shoulder of the road and bumped onto the big tree along the side of the road that caused of instantaneous death of the victim. Upon verification the said vehicle was loaded of 300 bags of wood charcoal when asked for the legality to transport of the said forest product, the suspects were not able to present any documents hence, arrest was made. Furthermore based on the medical result the suspect was positive in intoxicating liquor. Necessary documents are being prepared for filing of case mentioned above against the suspects.
