
Respectfully forwarded is the memorandum dated June 8, 2022 from CENRO Quezon, Palawan with pertinent enclosures relative on the above cited-subject.






Hereunder are the activities undertaken, to wit:

1. Letter dated March 24, 2022, informing the CBFM PO that the project proposal entitled Agroforestry and Fuelwood Plantation amounting to one million two hundred seven thousand pesos (P1,207,000.00) was already approved funded under CBFM-CARP thru SAA No. CO-R4B-101-2022-03-279 (*hereto attached*);
2. Conducted meeting to present and discuss the Memorandum of Agreement (MOA) and Work and Financial Plan (WFP) last March 29, 2022 and subsequently finalized the WFP and signed the MOA by the PO President, Belly C. Bungar on March 30, 2022;
3. Transmitted the MOA and WFP for review and signature on April 12, 2022;
4. Conducted initial perimeter survey within MUMA on April 22, 2022 wherein the surveyed area for CBFM-CARP project falls outside the CBFM area, thus the team conducted another survey on April 29, 2022 to identify areas to complete the required forty (40) hectares for the said CBFM-CARP project;
5. Documents pertaining to the payment of mobilization fund was already transmitted to PENRO on May 6, 2022;

Please be informed that this Office is still waiting of the approved Work and Financial Plan, as one of the requirements for the payment of the said mobilization fund. Hence, MUMA started to establish their nursery and raise/produce planting materials such as mahogany, mangium and cashew.






