This is in reference to the Memorandum from the Regional Executive Director Lormelyn E. Claudio dated June 23, 2022 regarding the above-cited subject on the issues and concerns raised during the blended meeting on June 14, 2022.

Please be informed that during the time of the undersigned assumption of duty on June 13, 2022 as per Special Order No. 2022-417 to June 30, 2022 this Office have accomplished the following activities with regards to the issues and concerns raised during blended meeting on June 14, 2021, to wit;

- 1. Created Task Force Team of CENRO Coron assigned to conduct weekly patrolling and monitoring in Reclamation Site, Quarry sites, and its adjacent areas;
- 2. Submitted request to the Regional Office for the Technical Team to conduct valuation and assessment of mangrove damages within the reclamation activities in Coron, Palawan on June 17, 2022;
- 3. Endorsed team composition for the conduct of Multi-Sectoral Inspection and Investigation on Environmental Issues and Concerns in Coron, Palawan for issuance of Regional Special Order on June 29, 2022;
- 4. Issued Notice of Violation to the proponents of Coron Bay Development Project (CBDP), New Public Market Project of Coron Local Government;
- 5. Convened with Coron Municipal Engineer, Engr. Ike D. Parangue and Municipal Planning, Engr. Michael Adrian Fababeir at CENRO Office on June 28, 2022 regarding LGU projects with applied Gratuitous Special Land Use Permit (GSLUP), New Public Market Project and Housing Project located at Brgys. Poblacion 6 and San Nicolas, Coron, Palawan; and
- 6. Sent letters to Barangay Captains of Polacion 1, 2, 3, 4 and 5 regarding solid waste management.
- 7. Served letter to Mr. Vicente Fernandez as manifestation for the investigation and inspection works to be conducted in his private property located at Poblacion 6, Coron, Palawan at the back of Fernvale Subdivision scheduled on June 30, 2022.

To date, no illegal operation and reclamation activities were observed at CBDP, New Public Market Project and Quarry Sites. However, flooding in Brgy. 3, 5 and reclamation site on June 26, 2022 (night) which result siltation in the reclamation site were noteworthy. Based on the interview to the local, flooding happens due to heavy rain and inadequate drainage system in the area.

Further, investigation within the property of Mr. Vicente Fernandez were not yet done because the management of Fernvale subdivision does not allow the passing-through of any person through their property and that the said area is privately gated.


