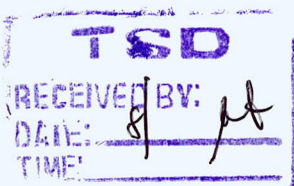
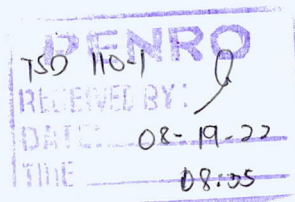


After satisfying the requirements of the said application, this Bureau has decided to grant an ECC for the above-mentioned project.

This refers to the application of Mrs. Proserfina M. Delos Trinos for issuance of permit to cut fifty-two (52) naturally grown Rain tree (Acacia) species within a private land covered by Transfer Certificate of Title (TCT) No. T-5758 located in Barangay Aguas, Rizal, Occidental Mindoro.

Analysis and evaluation of this office on the submitted inventory data/tally sheets shows that fifty-two (52) naturally grown Rain tree (Acacia) species with equivalent total volume of 123.47 cu.m. or net harvestable volume of 86.43 cu.m. after deducting the 30% allowance for internal defects and harvesting inefficiency are subject for cutting. The volume of the trees was computed following the Regional Volume Equation shown below:

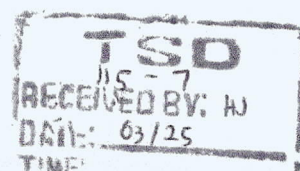
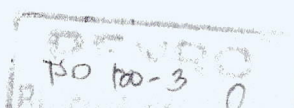
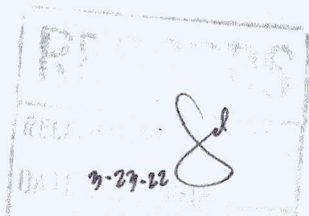
