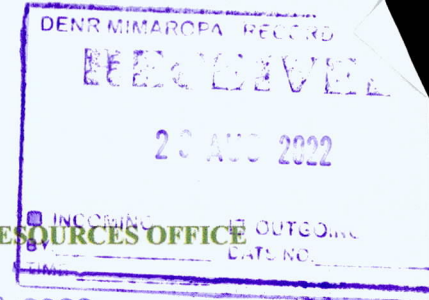

6. Any document/proof showing the date when applicant started its operation, construction or development over the applied area

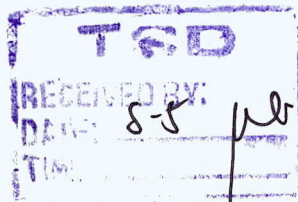
