I. EVALUATION OF THE COURSE:

The training-workshop aims the following:

- Strengthen the efforts of the Department in protecting the forests and to enhance the implementation of Lawin Forest and Biodiversity Protection System;
- Provide assistance and guide to the Lawin Data Managers in implementing their duties;
- Provide update on the status of the implementation of the LFBPS in the country;
- Assess the patrol data of the field offices;
- Enhance the capabilities of data managers to evaluate and analyse Lawin patrol data;
- Capacitate/train the participants on the proper evaluation of patrol data submitted by the patrollers and determine what is the suitable action upon the assessment of the patrol data.

The following were the topics discussed during the workshop:

Presentation of Patrols for Deletion and Updates

The FMB representatives showed the different patrol data. Patrols to be deleted were same or duplicated patrols, test data accidentally added, those outside of the Conservation Areas (CA) and those that do not followed the 1 observation every 100 meters. Patrols to be updated were those that contain GPS errors, covering return routes and those covering inside to outside of the CA and vice versa.

• Refreshing of Different Roles

- Patrollers at least 4 people (1 species identifier, 1 Cybertracker operator, 1 guide/knowledgeable of the area and 1 in-charge in logistics)
- Patrol Organizer can either be PASu, CENRO or PENRO (prepare patrol plans, organizes and deploys patrol teams, identifies priority illegal logging hotspots and highly conservation area)
- Data Manager manages observation records, create and submit reports of observation records and creates data models for SMART and Cybertracker, troubleshoots the involved software
- Resource Manager Either CENRO, PENRO or RED who has the mandate to manage the respective forest area, implements responses and requests reports from data manager.
- Environmental Law Enforcers and Institutional Support can be deputized patrollers or dedicated group at the DENR or LGUs and may include PNP, multi-sectoral groups like task force who enacts environmental law enforcement and record the observations, evidences, etc. using the cybertracker app.

Impression/Comments:

The event was very informative especially to us Lawin data managers. Hoping for future related activities and new and improved Lawin System with no or less error compared to the existing system.

II. RELEVANCE OF THE LEARNING EVENT TO PARTICIPANT'S WORK/FUNCTION:

The learning from the training is very important to me because I am the Lawin Data Manager of the Office who maintains the Lawin Forest and Biodiversity Protection System. Being refreshed with the system really helps me in performing my duties and responsibilities.

III. RECOMMENDATIONS:

It is recommended that I will be one of the participants of the future trainings related to my work for my improvement which will be helpful in performing my duties and obligations for Office's accomplishment and enhancement including Lawin Data Managers Conference and future system upgrades. May I suggest that representatives from FMB went to the field offices to held refresher course to the patrollers for a more focused group discussions. I also recommend the said participants to conduct Lawin patrolling inside the conservation areas for them to interact with patrollers since I, as the data managers, cannot totally or perfectly inform or express the different issues or concerns of the patrollers.
