This pertains to the application of Mr. Ariel N. Ola for Forest Land Use Agreement for Tourism purposes (FLAgT) covering a total area of 3.39 hectares of forest land located in Brgy. Ino, Mogpog, Marinduque.

Review and evaluation of the submitted documents disclosed that the following requirements to support the application are lacking, to wit:

1. Copy of Official Receipt of payment of application fee;
2. Appropriate clearance from the NCIP;
3. Endorsement from Local Government Unit (Sangguniang Barangay concerned); and
4. Tourism Development Plan (TDP) prepared by the Local Government Unit (LGU) and duly approved by the Department of Tourism.


**if not yet available, clearance/certification issued by municipal tourism officer. The certification should manifest that the proposed or existing tourism facilities is within the ambit of the forest land use plan as incorporated in its comprehensive land use plan and approved tourism framework plan for the locality.*

In addition to the abovementioned requirements, you are hereby instructed to submit an inspection report relative to the subject application which shall also include 100% timber inventory and photo documentation with geotags.

In this regard, we are returning the entire subject folder for further review and evaluation as to its completeness, and for proper indorsement. Please coordinate and advise the proponent to submit the above-mentioned documents to facilitate processing of the FLAgT application.

Attached is the accomplished checklist for your guidance.
