



After his death, all of us farmers continue to preside up to this day in the said area but, unfortunately, there is a person who approached us and convinced us to mortgage the parcel of land to him. But we are victims of his scam objectives in the name of "~~Excm~~ventura" and he processed the title of land to transfer it under his name.

Therefore, we request your Honorable Office to order the Secretary of DENR to cancel the title application of this person immediately. To order the Secretary of DAR to organize a task force to investigate and process the relocation survey; and to order the Secretary of DAR to process the CARP implementation processing of CLOA for each farmers mentioned in this Petition.

That we request to order the DENR Secretary to provide to this parcel of land DENR Relocation Survey. That we request the Land Registry Authority or Registry of Deeds to furnish us a copy of Titles and other documents under the name of Luis Valiente especially for CARP survey and DENR relocation. *That we request from DENR Cadastral Survey Mapping.*


