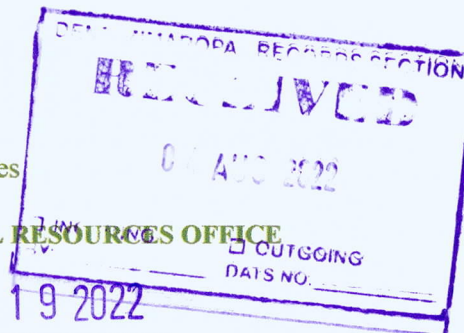

ORDER

In today's hearing, Public Prosecutor Warren Wesley M. Malalad, Public Attorney Jeffrey M. Mercado, Hector S. Aragones, Jr., and the accused, are all present.

Before arraignment, Prosecutor Malalad moved that the correct name and alias of herein accused Julito Casas y Zabala @ "Dong" and the word "accuses" be inserted in the Information, which was granted.

Atty. Mercado was appointed *counsel de oficio* and manifested that the accused will plead **GUILTY** to the offense charged. After having explained to him the nature and consequences of his plea and having manifested to have understood the same, accused was arraigned in *Tagalog*, a language known and understood by him. He entered a plea of **GUILTY** to the offense charged. Let his plea be entered in the record.

WHEREFORE, judgment is hereby rendered finding **Julito Casas y Zabala @ "Dong", GUILTY** beyond reasonable doubt of unlawful possession of chain saw defined and penalized under Section 7 (1) of RA No. 9175 and is hereby sentenced to pay a **fine of Fifteen Thousand Pesos (P15,000.00)** with subsidiary imprisonment in case of insolvency.

The **STIHL chain saw without serial number** seized in connection with this case, which is under the custody of the DENR-CENRO in San Jose is declared **confiscated and forfeited** in favor of the government to be disposed of in accordance with law.

Atty. Mercado manifested that the accused is willing to pay the fine out of his cash bond and moved for its release. Acting thereon, the cash bond posted by the accused on June 06, 2022 in the amount of Ten Thousand Pesos (P10,000.00) under Official Receipt No. 2685139D is hereby ordered **released** upon compliance with the requirements of this Court and the **fine** imposed upon him shall be satisfied therefrom. The balance of Five Thousand Pesos (P5,000.00) shall be paid immediately by the accused to this Court.
