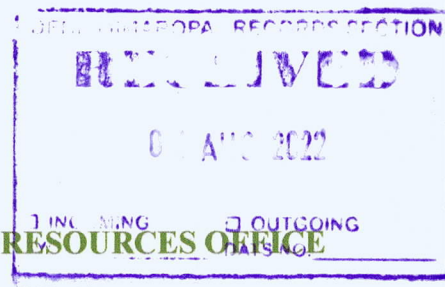

**RESOLUTION No. 2022-036**

This pertains to the apprehension of the Seventeen (17) pieces of Bulabog lumber with a total volume of 388.31 bdft, at So. Calachuchi, Brgy. Alibog, Magsaysay, Occidental Mindoro, on February 2, 2022, at around 2:00 in the afternoon by the Personnel from Enforcement and Monitoring Section (EMS) by the DENR CENRO, San Jose, Occidental Mindoro.

**The facts of the subject case are as follows, to wit:**

1. That on February 2, 2022 the Enforcement and Monitoring Section (EMS) Personnel's of the DENR received an information that there were illegal lumbers at So. Calachuchi, Brgy. Alibog, Magsaysay, Occidental Mindoro. At around 2:00 in the afternoon the team found and apprehended seventeen (17) pieces of Bulabog lumber with a total volume of 388.31 bdft, that is found to be abandoned. *(Please see attached spot report and geo-tag photos)*
2. That the team apprehended Seventeen (17) pieces of Bulabog lumbers with a total volume of 388.31 bdft already cut into lumber. The said forest products were found abandoned. These was temporarily impounded at the DENR CENRO, San Jose Occidental Mindoro, for safekeeping. *(Please see attached spot report and apprehension receipt.)*
3. That the corresponding Apprehension Receipt with CENRO Control No.2022-F433 was issued by the apprehending officer headed by Forest Ranger Emmanuel G. Ignacio *(please see attached apprehension receipt)*
4. That after verifying the existence of a prima facie case against the offender, the Seizure Officer Forester III Hector S. Aragones, Jr. issued the Seizure Order with CENRO Control Number 022-F433 to Seventeen (17) pieces of Bulabog lumbers 2"x10"x13' One piece; 2"x11"x13' Two pieces; 2"x14"x12' Four pieces; 2"x14"x15' One piece; 2"x12"x12' One piece; 2"x10"x12' Three pieces; 2"x11"x12' One piece; 2"x11"x12' One piece; 2"x11"x8' Two pieces; 2"x10"x11' Two pieces with a total volume of 388.31 bdft.. *( please see attached seizure order)*



5. That a recapitulation and assessed value of the abandoned forest products was made by EMS Deputy Chief, Forester I Jomar B. Serquina. *(please see attached recapitulation and assessed value report)*
6. That a PABATID SA PUBLIKO (Notice to the Public) was posted on February 4, 11, 18, 2022 at conspicuous places such as at So. Calachuchi, Barangay Alibog and at the Brgy. Hall of Barangay Alibog, Magsaysay, Occidental Mindoro. *(please see attached Pabatid sa Publiko)*
7. That, no Administrative hearing was made because there was no claimant of the said abandoned forest products even though a Pabatid sa Publiko has been posted on 3 separate dates and at the conspicuous places of the area of concern. *(please see attached Pabatid sa Publiko)*

**The issues to be resolved in this case are as follow;**

1. Whether or not the Abandoned **SEVENTEEN (17) PIECES OF BULABOG LUMBERS 2"x10"x13' ONE PIECE; 2"x11"x13' TWO PIECES; 2"x14"x12' FOUR PIECES; 2"x14"x15' ONE PIECE; 2"x12"x12' ONE PIECE; 2"x10"x12' THREE PIECES; 2"x11"x12' ONE PIECE; 2"x11"x12' ONE PIECE; 2"x11"x8' TWO PIECES; 2"x10"x11' TWO PIECES WITH A TOTAL VOLUME OF 388.31 BDFT.** will be **confiscated in favor of the government.**

The grounds for apprehension and seizure of the forest products is valid, as the abandoned forest product is not supported with any cutting permit issued by the office of the DENR CENRO San Jose, Occidental Mindoro.

Presidential Decree No. 705, May 19, 1975, revising Presidential Decree No. 705 otherwise Known as the Forestry Reform Code of the Philippines, as amended by Executive Order No. 277 and republic Act No. 7161, states that;

**SECTION 77. Cutting, Gathering and/or collecting Timber, or Other Forest Products Without License.** – *Any person who shall cut, gather, collect, removed timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code*

xxx

**SECTION 77-A. Administrative Authority of the Department Head or His Duly Authorized Representative to Order Confiscation.** – *In all cases of violations of this Code or other forest laws, rules and regulations, the Department Head or his duly authorized representative, may order the confiscation of any forest products illegally cut, gathered, removed, or possessed or abandoned, and all conveyances used either by land, water or air in the commission of the offense and to dispose of the same in accordance with pertinent laws, regulations or policies on the matter.*

***Sec. 2. Items subject to apprehension, seizure, confiscation and forfeiture.***

- a. ***ILLEGAL FOREST PRODUCTS*** - Any forest products(s) defined in Section 1(e) above that are removed, cut, collected, processed and/or transported: (a) without the requisite authorization or permit; or (b) with incomplete required supporting documents 1; (c) with genuine authorizations or permits and/or supporting documentation that have an expired validity, have been cancelled or that contain forged entries; or (d) with spurious (fake) authorizations, permits and/or supporting documentation. In implementing these Rules, original documents shall be required at all times to actually accompany any forest products being moved or transported to any place and for any purpose. Whenever the requisite authorization and/or supporting documentation are required to but do not actually accompany the forest products, such absence constitutes a violation covered by these Rules.

***Sec. 8. Abandoned Illegal Forest Products.***

The following procedures apply in cases where illegal forest products and other items listed in Section 2 hereof are abandoned, or when the owner, claimant, custodian or other interested Party(ies) is unknown, cannot be determined, or cannot otherwise be found.

Par.3. Summary Seizure/Confiscation Proceedings shall be conducted by the hearing officer designated in these rules. In such cases the Notice of Hearing shall be posted at least three (3) times, once a every week for three (3) consecutive weeks, in at least three (3) public places, including but not limited to: (a) the Barangay Hall of the apprehension site; (b) the Bulletin Board of the DENR Offices where the Proceedings will be conducted, and (c) at the Municipal Hall of the apprehension site.

Should the owner, claimant or other interested Party fail to appear at the Proceedings, such failure shall be deemed a waiver of the right to appear and of any/all rights to the items apprehended in favor of the Government.

2. The enumerated statements of facts, pieces of evidence and circumstances surrounding the above stated case, shows that the apprehended abandoned **SEVENTEEN (17) PIECES OF BULABOG LUMBERS 2"x10"x13' ONE PIECE; 2"x11"x13' TWO PIECES; 2"x14"x12' FOUR PIECES; 2"x14"x15' ONE PIECE; 2"x12"x12' ONE PIECE; 2"x10"x12' THREE PIECES; 2"x11"x12' ONE PIECE; 2"x11"x12' ONE PIECE; 2"x11"x8' TWO PIECES; 2"x10"x11' TWO PIECES WITH A TOTAL VOLUME OF 388.31 BDFT.** shall be confiscated in favour of the government since those lumbers are product of an illegal act.

Based in the case at bar, the cutting of forest products without legal documents if proven is a violation of Section 77 of PD 705 as amended by Executive Order No. 277 and Republic Act 7161 thus subject to confiscation. Moreover, in occasion where the said illegal forest products was said to be abandoned it shall also be confiscated in favor of the Government, under Section 8 Par. 3 of Department Administrative Order (DAO) 97-32.

**Wherefore,** pursuant to Section 77 and 77-a of PD 705 as amended, section 2 and 7 of DENR Administrative Order No. 97-32, series of 1990 and based on DAO 98-24 (Manual of Approvals) the following are hereby recommended:

1. The abandoned **SEVENTEEN (17) PIECES OF BULABOG LUMBERS** **2"x10"x13' ONE PIECE; 2"x11"x13' TWO PIECES; 2"x14"x12' FOUR PIECES; 2"x14"x15' ONE PIECE; 2"x12"x12' ONE PIECE; 2"x10"x12' THREE PIECES; 2"x11"x12' ONE PIECE; 2"x11"x12' ONE PIECE; 2"x11"x8' TWO PIECES; 2"x10"x11' TWO PIECES** **WITH A TOTAL VOLUME OF 388.31 BDFT.** shall be confiscated in favour of the government since those lumbers are products of an illegal act.

**RESOLUTION No. 2022-036**

This pertains to the apprehension of the Seventeen (17) pieces of Bulabog lumber with a total volume of 388.31 bdft, at So. Calachuchi, Brgy. Alibog, Magsaysay, Occidental Mindoro, on February 2, 2022, at around 2:00 in the afternoon by the Personnel from Enforcement and Monitoring Section (EMS) by the DENR CENRO, San Jose, Occidental Mindoro.

**The facts of the subject case are as follows, to wit:**

1. That on February 2, 2022 the Enforcement and Monitoring Section (EMS) Personnel's of the DENR received an information that there were illegal lumbers at So. Calachuchi, Brgy. Alibog, Magsaysay, Occidental Mindoro. At around 2:00 in the afternoon the team found and apprehended seventeen (17) pieces of Bulabog lumber with a total volume of 388.31 bdft, that is found to be abandoned. *(Please see attached spot report and geo-tag photos)*
2. That the team apprehended Seventeen (17) pieces of Bulabog lumbers with a total volume of 388.31 bdft already cut into lumber. The said forest products were found abandoned. These was temporarily impounded at the DENR CENRO, San Jose Occidental Mindoro, for safekeeping. *(Please see attached spot report and apprehension receipt.)*
3. That the corresponding Apprehension Receipt with CENRO Control No.2022-F433 was issued by the apprehending officer headed by Forest Ranger Emmanuel G. Ignacio *(please see attached apprehension receipt)*
4. That after verifying the existence of a prima facie case against the offender, the Seizure Officer Forester III Hector S. Aragones, Jr. issued the Seizure Order with CENRO Control Number 022-F433 to Seventeen (17) pieces of Bulabog lumbers 2"x10"x13' One piece; 2"x11"x13' Two pieces; 2"x14"x12' Four pieces; 2"x14"x15' One piece; 2"x12"x12' One piece; 2"x10"x12' Three pieces; 2"x11"x12' One piece; 2"x11"x12' One piece; 2"x11"x8' Two pieces; 2"x10"x11' Two pieces with a total volume of 388.31 bdft.. *( please see attached seizure order)*



5. That a recapitulation and assessed value of the abandoned forest products was made by EMS Deputy Chief, Forester I Jomar B. Serquina. *(please see attached recapitulation and assessed value report)*
6. That a PABATID SA PUBLIKO (Notice to the Public) was posted on February 4, 11, 18, 2022 at conspicuous places such as at So. Calachuchi, Barangay Alibog and at the Brgy. Hall of Barangay Alibog, Magsaysay, Occidental Mindoro. *(please see attached Pabatid sa Publiko)*
7. That, no Administrative hearing was made because there was no claimant of the said abandoned forest products even though a Pabatid sa Publiko has been posted on 3 separate dates and at the conspicuous places of the area of concern. *(please see attached Pabatid sa Publiko)*

**The issues to be resolved in this case are as follow;**

1. Whether or not the Abandoned **SEVENTEEN (17) PIECES OF BULABOG LUMBERS 2"x10"x13' ONE PIECE; 2"x11"x13' TWO PIECES; 2"x14"x12' FOUR PIECES; 2"x14"x15' ONE PIECE; 2"x12"x12' ONE PIECE; 2"x10"x12' THREE PIECES; 2"x11"x12' ONE PIECE; 2"x11"x12' ONE PIECE; 2"x11"x8' TWO PIECES; 2"x10"x11' TWO PIECES WITH A TOTAL VOLUME OF 388.31 BDFT.** will be **confiscated in favor of the government.**

The grounds for apprehension and seizure of the forest products is valid, as the abandoned forest product is not supported with any cutting permit issued by the office of the DENR CENRO San Jose, Occidental Mindoro.

Presidential Decree No. 705, May 19, 1975, revising Presidential Decree No. 705 otherwise Known as the Forestry Reform Code of the Philippines, as amended by Executive Order No. 277 and republic Act No. 7161, states that;

***SECTION 77. Cutting, Gathering and/or collecting Timber, or Other Forest Products Without License.*** – Any person who shall cut, gather, collect, removed timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code

xxx

***SECTION 77-A. Administrative Authority of the Department Head or His Duly Authorized Representative to Order Confiscation.*** – In all cases of violations of this Code or other forest laws, rules and regulations, the Department Head or his duly authorized representative, may order the confiscation of any forest products illegally cut, gathered, removed, or possessed or abandoned, and all conveyances used either by land, water or air in the commission of the offense and to dispose of the same in accordance with pertinent laws, regulations or policies on the matter.

xxx



***Sec. 2. Items subject to apprehension, seizure, confiscation and forfeiture.***

- a. ***ILLEGAL FOREST PRODUCTS*** - Any forest products(s) defined in Section 1(e) above that are removed, cut, collected, processed and/or transported: (a) without the requisite authorization or permit; or (b) with incomplete required supporting documents; (c) with genuine authorizations or permits and/or supporting documentation that have an expired validity, have been cancelled or that contain forged entries; or (d) with spurious (fake) authorizations, permits and/or supporting documentation. In implementing these Rules, original documents shall be required at all times to actually accompany any forest products being moved or transported to any place and for any purpose. Whenever the requisite authorization and/or supporting documentation are required to but do not actually accompany the forest products, such absence constitutes a violation covered by these Rules.

***Sec. 8. Abandoned Illegal Forest Products.***

The following procedures apply in cases where illegal forest products and other items listed in Section 2 hereof are abandoned, or when the owner, claimant, custodian or other interested Party(ies) is unknown, cannot be determined, or cannot otherwise be found.

Par.3. Summary Seizure/Confiscation Proceedings shall be conducted by the hearing officer designated in these rules. In such cases the Notice of Hearing shall be posted at least three (3) times, once a every week for three (3) consecutive weeks, in at least three (3) public places, including but not limited to: (a) the Barangay Hall of the apprehension site; (b) the Bulletin Board of the DENR Offices where the Proceedings will be conducted, and (c) at the Municipal Hall of the apprehension site.

Should the owner, claimant or other interested Party fail to appear at the Proceedings, such failure shall be deemed a waiver of the right to appear and of any/all rights to the items apprehended in favor of the Government.

2.
