RE: APPREHENSION OF ABANDONED ONE HUNDRED TWENTY SEVEN (127) PIECES OF GMELINA LUMBERS WITH A DIMESION OF NINETY TWO (92) PIECES 1"x6"x6' GMELINA; TWENTY FIVE (25) PIECES 1"x6"x10' GMELINA; TEN (10) PIECES 1"x6"x8' GMELINA; WITH A TOTAL VOLUME OF 441.00 BDFT. AND ONE (1) UNIT OF STIHL CHAINSAW WITH A SERIAL NO. 04081675-A, AT BRGY. ANSIRAY, SAN JOSE, OCCIDENTAL MINDORO, ON MARCH 16, 2022 AT AROUND 2:49 IN THE AFTERNOON.

### RESOLUTION No. 2022-039

This pertains to the apprehension of the Abandoned One Hundred Twenty Seven (127) pieces of Gmelina lumbers with a total volume of 441.00 bdft., and One (1) unit Chainsaw with a serial number 04081675-A at Brgy. Ansiray, San Jose, Occidental Mindoro, on March 16, 2022, at around 2:49 in the afternoon by the Personnel from Enforcement and Monitoring Section (EMS) by the DENR CENRO, San Jose, Occidental Mindoro.

### The facts of the subject case are as follows, to wit:

- 1. That on March 16, 2022, the Enforcement and Monitoring Section (EMS) Personnel's of the DENR through Chief EMS Hector S. Aragones Jr. received instruction from CENRO Efren Delos Reyes that a vital information from the anonymous citizen from Brgy. Ansiray, San Jose, Occidental Mindoro signifying that there has been an ongoing illegal activity regarding the cutting of trees with the forestland of the same barangay. The team proceeded at the said area and they found and apprehended scattered undocumented Gmelina lumbers as well as one (1) unit of Chainsaw with a serial number 04081675-A. The said forest products and the chainsaw were found abandoned. (*Please see attached spot report and geo-tag photos*)
- 2. That the team apprehended One Hundred Twenty Seven (127) pieces of Gmelina lumbers with a total volume of 441.00 bdft. and One (1) unit Chainsaw with a serial number 04081675-A. The said forest products and the chainsaw were found abandoned. These was temporarily impounded at the DENR CENRO, San Jose, Occidental Mindoro, for safekeeping. (Please see attached spot report.)
- 3. That the corresponding Apprehension Receipt with CENRO Control No.2022-F439 was issued by the apprehending officer Forest Technician Dominic L. Vidal. (please see attached apprehension receipt)
- 4. That after verifying the existence of a prima facie case against the offender, the Seizure Officer Forester III Hector S. Aragones, Jr. issued the Seizure Order with CENRO Control Number 2021-F439 for One Hundred Twenty Seven (127) pieces of Gmelina lumbers with a total volume of 441.00 bdft. and One (1) unit Chainsaw with a serial number 04081675-A. (please see attached seizure order)

- That a recapitulation and assessed value of the abandoned forest products was made by EMS Deputy Chief, Forester I Jomar B. Serquina. (please see attached recapitulation and assessed value report)
- 6. That a PABATID SA PUBLIKO (Notice to the Public) was posted in the following dates of March 29, 2022 and April 5 and 12, 2022 in that succeeding days and in conspicuous places such as at the Brgy. Hall of Barangay Ansiray, San Jose, Occidental Mindoro. ( please see attached PABATID SA PUBLIKO)
- 7. No Administrative hearing was made because the said forest products was ABANDONED.

The issues to be resolved in this case are as follow;

- 1. Whether or not the Abandoned ONE HUNDRED TWENTY SEVEN (127) PIECES OF GMELINA LUMBERS WITH A DIMESION OF NINETY TWO (92) PIECES 1"x6"x6' GMELINA; TWENTY FIVE (25) PIECES 1"x6"x10' GMELINA; TEN (10) PIECES 1"x6"x8' GMELINA; WITH A TOTAL VOLUME OF 441.00 BDFT., will be confiscated in favor of the government.
- 2. Whether or not, the apprehended AND ONE (1) UNIT OF STIHL CHAINSAW WITH A SERIAL NO. 04081675-A. Shall be confiscated in favor of the government.

The grounds for apprehension and seizure of the forest products and the chain saw is valid, as the abandoned forest product is not supported with any cutting permit and the chainsaw registration permit issued by the office of the DENR CENRO San Jose, Occidental Mindoro.

Presidential Decree No. 705, May 19, 1975, revising Presidential Decree No. 705 otherwise Known as the Forestry Reform Code of the Philippines, as amended by Executive Order No. 277 and republic Act No. 7161, states that;

SECTION 77. Cutting, Gathering and/or collecting Timber, or Other Forest Products Without License. — Any person who shall cut, gather, collect, removed timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code

xxx

SECTION 77-A. Administrative Authority of the Department Head or His Duly Authorized Representative to Order Confiscation. — In all cases of violations of this Code or other forest laws, rules and regulations, the Department Head or his duly authorized representative, may order the confiscation of any forest products illegally cut, gathered, removed, or possessed or abandoned, and all conveyances used either by land, water or air in the commission of the offense and to dispose of the same in accordance with pertinent laws, regulations or policies on the matter.

Sec. 2. Items subject to apprehension, seizure, confiscation and forfeiture.

a. ILLEGAL FOREST PRODUCTS - Any forest products(s) defined in Section 1(e) above that are removed, cut, collected, processed and/or transported: (a) without the requisite authorization or permit; or (b) with incomplete required supporting documents 1; (c) with genuine authorizations or permits and/or supporting documentation that have an expired validity, have been cancelled or that contain forged entries; or (d) with spurious (fake) authorizations, permits and/or supporting documentation. In implementing these Rules, original documents shall be required at all times to actually accompany any forest products being moved or transported to any place and for any purpose. Whenever the requisite authorization and/or supporting documentation are required to but do not actually accompany the forest products, such absence constitutes a violation covered by these Rules.

### CHAIN SAW ACT RA 9175

Presidential Decree No. 9175, November 7, 2002, AN ACT REGULATING THE OWNERSHIP, POSSESSION, SALE, IMPORTATION AND USE OF CHAIN SAWS, PENALIZING VIOLATIONS THEREOF AND FOR OTHER PURPOSES, states that;

SECTION 7. Cutting, Gathering and/or collecting Timber, or Other Forest Products Without License. — Selling, Purchasing, Re-selling, Transferring, Distributing or Possessing a Chain Saw Without a Proper Permit. — Any person who sells, purchases, transfer the ownership, distributes or otherwise disposes or possesses a chain saw without first securing the necessary permit from the Department shall be punished with imprisonment of four (4) years, two (2) months and one (1) day to six (6) years or a fine of not less than Fifteen thousand pesos (P15,000.00) but not more Thirty thousand pesos (30,000.00) or both at the discretion of the court, and the chain saw/s confiscated in favor of the government.

SECTION 14. DAO 2003-04. — CONFISCATION OF CHAINSAWS. — Chainsaws used in the cutting, gathering, collecting, removing and/or processing timber or forest products without legal documents shall be subject to Judicial and/or administrative confiscation under Section 68 and 68A of PD 705 as amended, and as implemented by DAO 97-32 and other subsequent forestry regulations that may be promulgated.

Department Administrative Order No. 2003-04

Sec. 12. Items subject to apprehension, seizure, confiscation and forfeiture,

12.1 SELLING, PURCHASING, RE-SELLING, TRANSFERRING, DISTRIBUTING, OR POSSESSING, A CHAINSAWA WITHOUT A PROPER PERMIT- Any person who sells, purchases, transfers the ownership, distributes, or otherwise disposes or possess a chainsaw without first securing the necessary permit from the Department shall be punished with imprisonment of four (4) years, two (2) months and one (1) day to six (6) years or a fine of not less that Fifteen Thousand (15,000) pesos but not more than

Thirty Thousand Pesos (P30,000.00) or both at the discretion of the court and the chainsaw confiscated in favor of the government

### **DEPARTMENT ADMINISTRATIVE ORDER 97-32**

### Sec. 8. Abandoned Illegal Forest Products.

The following procedures apply in cases where illegal forest products and other items listed in Section 2 hereof are abandoned, or when the owner, claimant, custodian or other interested Patry(ies) is unknown, cannot be determined, or cannot otherwise be found.

Par.3. Summary Seizure/Confiscation Proceedings shall be conducted by the hearing officer designated in these rules. In such cases the Notice of Hearing shall be posted at least three (3) times, once a every week for three (3) consecutive weeks, in at least three (3) public places, including but not limited to: (a) the Barangay Hall of the apprehension site; (b) the Bulletin Board of the DENR Offices where the Proceedings will be conducted, and (c) at the Municipal Hall of the apprehension site.

Should the owner, claimant or other interested Party fail to appear at the Proceedings, such failure shall be deemed a waiver of the right to appear and of any/all rights to the items apprehended in favor of the Government.

### Sec. 13 THE FOLLOWING CHAINSAW ARE SUBJECT TO CONFISCATION

13.1. Chainsaws sold, purchased, resold, transferred, distributed, leased, rented, lent or possessed without proper permit or authority from the Department.

3. The enumerated statements of facts, pieces of evidence and circumstances surrounding the above stated case, shows that the apprehended abandoned ONE HUNDRED TWENTY SEVEN (127) PIECES OF GMELINA LUMBERS WITH A DIMESION OF NINETY TWO (92) PIECES 1"x6"x6" (GMELINA; TWENTY FIVE (25) PIECES 1"x6"x10' GMELINA; TEN (10) PIECES 1"x6"x8' GMELINA; WITH A TOTAL VOLUME OF 441.00 BDFT. AND ONE (1) UNIT OF STIHL CHAINSAW WITH A SERIAL NO. 04081675-A, shall be confiscated in favour of the government since those lumbers are product of an illegal act.

Based in the case at bar, the cutting of forest products without legal documents if proven is a violation of Section 77 of PD 705 as amended by Executive Order No. 277 and Republic Act 7161 AND the use One (1) unit of Chain saw thus subject to confiscation as it violates RA 9175 and Department Administrative Order (DAO) 2003-04. Moreover, in occasion where the said illegal forest products was said to be abandoned it shall also be confiscated in favor of the Government, under Section 8 Par. 3 of Department Administrative Order (DAO) 97-32.

Wherefore, pursuant to Section 77 and 77-a of PD 705 as amended, section 2 and 7 of DENR Administrative Order No. 97-32, series of 1990 and based on DAO 98-24 (Manual of Approvals) the following are hereby recommended:

1. The abandoned ONE HUNDRED TWENTY SEVEN (127) PIECES OF GMELINA LUMBERS WITH A DIMESION OF NINETY TWO (92) PIECES 1"x6"x6' GMELINA; TWENTY FIVE (25) PIECES

1"x6"x10' GMELINA; TEN (10) PIECES 1"x6"x8' GMELINA; WITH A TOTAL VOLUME OF 441.00 BDFT. AND ONE (1) UNIT OF STIHL CHAINSAW WITH A SERIAL NO. 04081675-A, shall be confiscated in favour of the government since those lumbers are product of an illegal act.

Submitted herewith is the report regarding the apprehension of the above mentioned subject:

- 1. That on the morning of March 16, 2021, EMS Chief Hector S. Aragones, Jr. received an instruction from CENR Officer Efren L. Delos Reves that a vital information from an anonymous citizen from Brgy. Ansiray, San Jose, Occidental Mindoro signifying that there has been an ongoing illegal activity regarding cutting of trees within the forest land of the same barangay.
- EMS Chief Hector S. Aragones, Jr. instructed EMS Deputy Chief Jomar B. Serquiña to conduct surveillance at the said area to verify the veracity of the said information.
- At around 12:00 noon, EMS Deputy Chief Jomar B. Serquiña together with Forest Rangers Delfin N. Casticimo, Jr., Carl Emmanuel A. Urieta, Ronald D. Fresnillo and Forest Protection Officers Louie James D. Antonio and Ednor C. Legaspi, Jr. and Deputized ENR Officer Emmanuel Pacaul proceeded to Brgy. Ansiray, Ilin Island, San Jose, Occidental Mindoro to conduct surveillance regarding the said information.
- 4. The team arrived at the said barangay at around 02:10 PM and proceeded to the Barangay Hall to properly coordinate with Brgy. Captain Marlon S. Ramintas and Barangay Kagawad Ricardo M. Sampilo regarding the said information. After that, the team proceeded to the said area to verify the information. (SEE ANNEX I)
- The team conducted surveillance in the said area and discovered stock piles of abandoned lumbers and STIHL chainsaw with tampered Serial No. 04081675-A within the vicinity. (SEE ANNEX II)

- 6. After that, the team conducted inventory of the said abandoned lumber and chainsaw. (SEE ANNEX III)
- 7. The team then hauled the said abandoned lumber with a volume of 100.00 board feet (12 pcs. 1x6x10), (10 pcs. 1x6x8) and chainsaw back to the DENR CENRO San Jose for safekeeping and left the remaining 341.00 board feet (92 pcs. 1x6x6), (13 pcs. 1x6x10) at the Barangay Hall of Brgy. Ansiray, Ilin Island, San Jose, Occidental Mindoro for temporary custody. (SEE ANNEX IV)

The team recommends to conduct close monitoring at the barangays of Ilin and Ambulong Islands and to intensify the conduct of IEC and coordination with the BLGU Officials.





#### **RESOLUTION No. 2022-039**

This pertains to the apprehension of the Abandoned One Hundred Twenty Seven (127) pieces of Gmelina lumbers with a total volume of 441.00 bdft., and One (1) unit Chainsaw with a serial number 04081675-A at Brgy. Ansiray, San Jose, Occidental Mindoro, on March 16, 2022, at around 2:49 in the afternoon by the Personnel from Enforcement and Monitoring Section (EMS) by the DENR CENRO, San Jose, Occidental Mindoro.

### The facts of the subject case are as follows, to wit:

- 1. That on March 16, 2022, the Enforcement and Monitoring Section (EMS) Personnel's of the DENR through Chief EMS Hector S. Aragones Jr. received instruction from CENRO Efren Delos Reyes that a vital information from the anonymous citizen from Brgy. Ansiray, San Jose, Occidental Mindoro signifying that there has been an ongoing illegal activity regarding the cutting of trees with the forestland of the same barangay. The team proceeded at the said area and they found and apprehended scattered undocumented Gmelina lumbers as well as one (1) unit of Chainsaw with a serial number 04081675-A. - 2. That the team apprehended One Hundred Twenty Seven (127) pieces of Gmelina lumbers with a total volume of 441.00 bdft. and One (1) unit Chainsaw with a serial number 04081675-A. The said forest products and the chainsaw were found abandoned. These was temporarily impounded at the DENR CENRO, San Jose, Occidental Mindoro, for safekeeping. (Please see attached spot report.)
- 3. That the corresponding Apprehension Receipt with CENRO Control No.2022-F439 was issued by the apprehending officer Forest Technician Dominic L. Vidal. (please see attached apprehension receipt)
- 4. That after verifying the existence of a prima facie case against the offender, the Seizure Officer Forester III Hector S. Aragones, Jr. issued the Seizure Order with CENRO Control Number 2021-F439 for One Hundred Twenty Seven (127) pieces of Gmelina lumbers with a total volume of 441.00 bdft. and One (1) unit Chainsaw with a serial number 04081675-A. (please see attached seizure order)

- 5. That a recapitulation and assessed value of the abandoned forest products was made by EMS Deputy Chief, Forester I Jomar B. Serquina. (please see attached recapitulation and assessed value report)

- 2. Whether or not, the apprehended AND ONE (1) UNIT OF STIHL CHAINSAW WITH A SERIAL NO. 04081675-A. Shall be confiscated in favor of the government.

The grounds for apprehension and seizure of the forest products and the chain saw is valid, as the abandoned forest product is not supported with any cutting permit and the chainsaw registration permit issued by the office of the DENR CENRO San Jose, Occidental Mindoro.

Presidential Decree No. 705, May 19, 1975, revising Presidential Decree No. 705 otherwise Known as the Forestry Reform Code of the Philippines, as amended by Executive Order No. 277 and republic Act No. 7161, states that;

SECTION 77. Cutting, Gathering and/or collecting Timber, or Other Forest Products Without License. — Any person who shall cut, gather, collect, removed timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code

xxx

SECTION 77-A. Administrative Authority of the Department Head or His Duty Authorized Representative to Order Confiscation. — In all cases of violations of this Code or other forest laws, rules and regulations, the Department Head or his duly authorized representative, may order the confiscation of any forest products illegally cut, gathered, removed, or possessed or abandoned, and all conveyances used either by land, water or air in the commission of the offense and to dispose of the same in accordance with pertinent laws, regulations or policies on the matter.

### Sec. 2. Items subject to apprehension, seizure, confiscation and forfeiture.

a. ILLEGAL FOREST PRODUCTS - Any forest products(s) defined in Section 1(e) above that are removed, cut, collected, processed and/or transported; (a) without the requisite authorization or permit; or (b) with incomplete required supporting documents 1; (c) with genuine authorizations or permits and/or supporting documentation that have an expired validity, have been cancelled or that contain forged entries; or (d) with spurious (fake) authorizations, permits and/or supporting documentation. In implementing these Rules, original documents shall be required at all times to actually accompany any forest products being moved or transported to any place and for any purpose. Whenever the requisite authorization and/or supporting documentation are required to but do not actually accompany the forest products, such absence constitutes a violation covered by these Rules.

#### CHAIN SAW ACT RA 9175

Presidential Decree No. 9175, November 7, 2002, AN ACT REGULATING THE OWNERSHIP, POSSESSION, SALE, IMPORTATION AND USE OF CHAIN SAWS, PENALIZING VIOLATIONS THEREOF AND FOR OTHER PURPOSES, states that:

**SECTION 7.** Cutting, Gathering and/or collecting Timber, or Other Forest Products Without License. — Selling, Purchasing, Re-selling, Transferring, Distributing or Possessing a Chain Saw Without a Proper Permit. — Any person who sells, purchases, transfer the ownership, distributes or otherwise disposes or possesses a chain saw without first securing the necessary permit from the Department shall be punished with imprisonment of four (4) years, two (2) months and one (1) day to six (6) years or a fine of not less than Fifteen thousand pesos (P15,000.00) but not more Thirty thousand pesos (30,000.00) or both at the discretion of the court, and the chain saw/s confiscated in favor of the government.

XXX

SECTION 14. DAO 2003-04. — CONFISCATION OF CHAINSAWS. — Chainsaws used in the cutting, gathering, collecting, removing and/or processing timber or forest products without legal documents shall be subject to Judicial and/or administrative confiscation under Section 68 and 68A of PD 705 as amended, and as implemented by DAO 97-32 and other subsequent forestry regulations that may be promulgated.

Department Administrative Order No. 2003-04

Sec. 12. Items subject to apprehension, seizure, confiscation and forfeiture.

12.1 SELLING, PURCHASING, RE-SELLING, TRANSFERRING, DISTRIBUTING, OR POSSESSING, A CHAINSAWA WITHOUT A PROPER PERMIT- Any person who sells, purchases, transfers the ownership, distributes, or otherwise disposes or possess a chainsaw without first securing the necessary permit from the Department shall be punished with imprisonment of four (4) years, two (2) months and one (1) day to six (6) years or a fine of not less that Fifteen Thousand (15,000) pesos but not more than

Thirty Thousand Pesos (P30,000.00) or both at the discretion of the court and the chainsaw confiscated in favor of the government

#### DEPARTMENT ADMINISTRATIVE ORDER 97-32

### Sec. 8. Abandoned Illegal Forest Products.

The following procedures apply in cases where illegal forest products and other items listed in Section 2 hereof are abandoned, or when the owner, claimant, custodian or other interested Patry(ies) is unknown, cannot be determined, or cannot otherwise be found.

Par.3. Summary Seizure/Confiscation Proceedings shall be conducted by the hearing officer designated in these rules. In such cases the Notice of Hearing shall be posted at least three (3) times, once a every week for three (3) consecutive weeks, in at least three (3) public places, including but not limited to: (a) the Barangay Hall of the apprehension site; (b) the Bulletin Board of the DENR Offices where the Proceedings will be conducted, and (c) at the Municipal Hall of the apprehension site.

Should the owner, claimant or other interested Party fail to appear at the Proceedings, such failure shall be deemed a waiver of the right to appear and of any/all rights to the items apprehended in favor of the Government.

xxx

### Sec.13 THE FOLLOWING CHAINSAW ARE SUBJECT TO CONFISCATION

13.1. Chainsaws sold, purchased, resold, transferred, distributed, leased, rented, lent or **possessed** without proper permit or authority from the Department.

3. The enumerated statements of facts, pieces of evidence and circumstances surrounding the above stated case, shows that the apprehended abandoned ONE HUNDRED TWENTY SEVEN (127) PIECES OF GMELINA LUMBERS WITH A DIMESION OF NINETY TWO (92) PIECES 1"x6"x6" (GMELINA; TWENTY FIVE (25) PIECES 1"x6"x10' GMELINA; TEN (10) PIECES 1"x6"x8' GMELINA; WITH A TOTAL VOLUME OF 441.00 BDFT. AND ONE (1) UNIT OF STIHL CHAINSAW WITH A SERIAL NO. 04081675-A, shall be confiscated in favour of the government since those lumbers are product of an illegal act.

Based in the case at bar, the cutting of forest products without legal documents if proven is a violation of Section 77 of PD 705 as amended by Executive Order No. 277 and Republic Act 7161 AND the use One (1) unit of Chain saw thus subject to confiscation as it violates RA 9175 and Department Administrative Order (DAO) 2003-04. Moreover, in occasion where the said illegal forest products was said to be abandoned it shall also be confiscated in favor of the Government, under Section 8 Par. 3 of Department Administrative Order (DAO) 97-32.

Wherefore, pursuant to Section 77 and 77-a of PD 705 as amended, section 2 and 7 of DENR Administrative Order No. 97-32, series of 1990 and based on DAO 98-24 (Manual of Approvals) the following are hereby recommended:

 The abandoned ONE HUNDRED TWENTY SEVEN (127) PIECES OF GMELINA LUMBERS WITH A DIMESION OF NINETY TWO (92) PIECES 1"x6"x6" GMELINA; TWENTY FIVE (25) PIECES 1"x6"x10' GMELINA; TEN (10) PIECES 1"x6"x8' GMELINA; WITH A TOTAL VOLUME OF 441.00 BDFT. AND ONE (1) UNIT OF STIHL CHAINSAW WITH A SERIAL NO. 04081675-A, shall be confiscated in favour of the government since those lumbers are product of an illegal act.

Submitted herewith is the report regarding the apprehension of the above mentioned subject:

- 1. That on the morning of March 16, 2021, EMS Chief Hector S. Aragones, Jr. received an instruction from CENR Officer Efren L. Delos Reyes that a vital information from an anonymous citizen from Brgy. Ansiray, San Jose, Occidental Mindoro signifying that there has been an ongoing illegal activity regarding cutting of trees within the forest land of the same barangay.
- 2. EMS Chief Hector S. Aragones, Jr. instructed EMS Deputy Chief Jomar B. Serquiña to conduct surveillance at the said area to verify the veracity of the said information.
- 3. At around 12:00 noon, EMS Deputy Chief Jomar B. Serquiña together with Forest Rangers Delfin N. Casticimo, Jr., Carl Emmanuel A. Urieta, Ronald D. Fresnillo and Forest Protection Officers Louie James D. Antonio and Ednor C. Legaspi, Jr. and Deputized ENR Officer Emmanuel Pacaul proceeded to Brgy. Ansiray, Ilin Island, San Jose, Occidental Mindoro to conduct surveillance regarding the said information.
- 4. The team arrived at the said barangay at around 02:10 PM and proceeded to the Barangay Hall to properly coordinate with Brgy. Captain Marlon S. Ramintas and Barangay Kagawad Ricardo M. Sampilo regarding the said information. After that, the team proceeded to the said area to verify the information. (SEE ANNEX I)
- The team conducted surveillance in the said area and discovered stock piles of abandoned lumbers and STIHL chainsaw with tampered Serial No. 04081675-A within the vicinity. (SEE ANNEX II)

- 6. After that, the team conducted inventory of the said abandoned lumber and chainsaw. (SEE ANNEX III)
- The team then hauled the said abandoned lumber with a volume of 100.00 board feet (12 pcs. 1x6x10), (10 pcs. 1x6x8) and chainsaw back to the DENR CENRO San Jose for safekeeping and left the remaining 341.00 board feet (92 pcs. 1x6x6), (13 pcs. 1x6x10) at the Barangay Hall of Brgy. Ansiray, Ilin Island, San Jose, Occidental Mindoro for temporary custody. (SEE ANNEX IV)

The team recommends to conduct close monitoring at the barangays of Ilin and Ambulong Islands and to intensify the conduct of IEC and coordination with the BLGU Officials.
