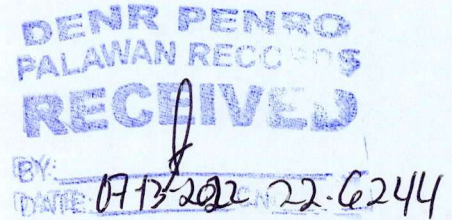

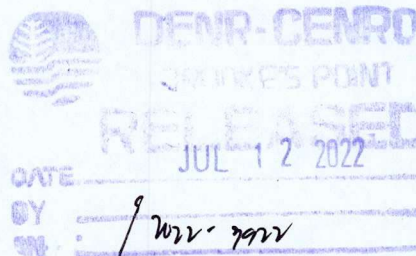

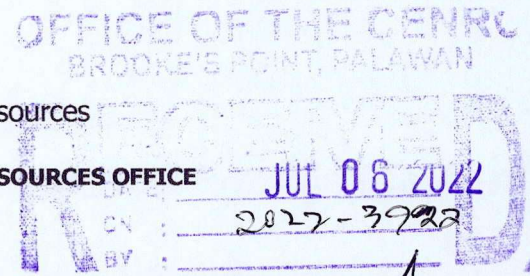

Information, Education and Communication campaign and other activities are continuously conducted by the personnel of this office in collaboration and participation of the Local Government Units and other partner agencies and companies within the jurisdiction of the CENRO. Several activities from April to June 2022 were conducted and participated, to wit:

I. Special Events and Celebration

1. Earth Day

Through the collaborative effort of CENRO Brooke's point personnel, Coral Bay Nickel Corporation and Rio Tuba Youth Organization, a mangrove planting was conducted on April 20, 2022 at CBNC Mangrove Rehabilitation Area, Barangay Rio Tuba, Bataraza, Palawan. The activity started by a short program wherein Forester Rachel Appie gave the importance of the celebration. Mr. Briccio Abela of CBNC also gave his message to the youth emphasizing the importance of mangrove especially during disasters like typhoon and storm surge. NGP Coordinator Arnil Junia explained the proper way of planting mangroves. There were 36 volunteers who participated in the activity wherein 3,000 propagules of bakawang babae and 200 potted seedlings of bakawang lalaki were planted in 1 hectare area.

On April 21, 2022, CENRO Brooke's Point personnel guested at MENRO Bataraza's regular program "Ridge to Reef Connect" at Pines FM Bataraza. Forest Technician I Emilyn Villanueva discussed about the Salient Features of PD 705 or the Revised Forestry Code of the

Philippines. LMO I Audre Rose Ocampo tackled about Land Disposition/ Titling. The processes and the requirements needed was emphasized especially now that the suspension in processing of titling was already lifted.

2. Month of the Ocean

Coral Bay Nickel Corporation (CBNC), led by the Environmental Management and Quality Control Section (EMQCS), organized Month of the Ocean celebration on May 14, 2022. This event is held at Ursula Island Game Refuge and Bird Sanctuary (UIGRBS) Ursula Island, Rio Tuba, Bataraza, Palawan. The event was attended by approximately fifty (50) active individuals from CBNC Community Relations (COMREL), General Affairs-Security, Stonewall Protective and Investigation Services Inc. (SPIS), Philippine Coast Guard (PCG)-Rio Tuba Sub-station, Local Government Unit-Rio Tuba (LGU-RT) and Protected Area Management Board (PAMB) Representatives.

CBNC Pollution Control Officer (PCO) and EMQCS General Supervisor, Mr. Jeb B. Badlon, officially opened the program by discussing how this event aims to highlight the importance and significance of conservation, protection, and sustainable management of our coastal and marine ecosystems. He said that, based on the study, our marine resources are now depleted because of overexploitation and destructive fishing activities.

Mr. Arnel R. Calinga, EMQCS Assistant and an Environmental Planner, discussed the sequence of activities. Participants started by happily picking up coastal debris around UIGRBS. SCUBASURERO (underwater debris collection) activity was also simultaneously done by licensed divers. Participants collected over hundred kilos of coastal and underwater debris from the island. Most of the debris collected is food wrappers, containers, glass and plastic beverage bottles, straws, and stirrers.

Mr. Randy C. Favila, EMQCS Senior Supervisor, led the renovation of the island's marine turtle hatchery fence to protect turtle eggs and hatchlings from predators. Mouse trapping is also done by EMQCS Assistant Mr. Rey Jean Mark A. Daanoy, to maintain the island free from rodent infestation.

On May 21, 2022, members of the Protected Area Management Board of Ursula Island Game Refuge and Bird Sanctuary (UIGRBS) and CENRO Brooke's Point conducted coastal clean-up at UIGRBS. Forty eight participants from MENRO and MPDO Bataraza, Philippine Marines, PENRO CDS, Coral Bay Nickel Corporation, BACHRISMUPAL and CENRO Brooke's Point actively participated on the said event. A total of 4 sacks or an estimated 20 kilos of non-biodegradable wastes were collected in the area. Collected wastes were then transferred to mainland Rio Tuba for proper disposal.

3. Philippine Environment Month, DENR 35th Anniversary, Arbor Day

On June 8, 2022, CENRO Brooke's Point in collaboration with LGU Barangay Inogbong, Bataraza, Palawan headed by Punong Barangay Maricris Alba, conducted tree planting activity at NGP Graduated Site CY 2012 Sitio Paratungon, Barangay Inogbong, Bataraza, Palawan. It was participated by 45 individuals from 2nd SOU-Maritime Group, BLGU Inogbong and CENRO Brooke's Point personnel. The activity started with a short program. A total of 1,000 seedlings were planted consists of Narra seedlings in a half hectare area. The activity aims to help restore the country's forest cover.

On June 10, 2022, CENRO Brooke's Point in collaboration with Brooke's Point Rural Health Unit conducted medical check-up of Uric, Cholesterol and Blood Sugar for CENRO Personnel. 33 personnel participated on the activity. The activity aims to ensure the health and wellness of CENRO personnel.

On June 13-17, 2022, CENRO Brooke's Point conducted the 1st Sports fest in celebration of DENR 35th Anniversary. IEC team facilitated the activity. Before the event, personnel were group into four (Pink Pantot, Red Bull, Blue Eagles and Green Sea Turtle). On the 1st day, a motorcade, zumba dance and an opening program was attended by personnel. It was followed by presentation of yell/ chant per group. The program was ended by a boodle fight. The 5-day activity consists of Palarong Pinoy such as Sail-a-Boat, Going to Market, Hulahoop Relay, Action Relay, Bunong Braso, Charade, Sack Race, Tug of War, Patintero, Bato Bola, Basagan Palayok, Pinoy Henyo and Family Feud. A Friendship Game (Basketball) was also held wherein youth of Brooke's Point and Philippine Coastguard participated. On the last day, awarding was held. Red Bull got the 3rd Place, Pink Pantot and Green Sea Turtle ties in 2nd Place and Blue Eagles won the 1st Place. According to the personnel who joined the activity, they really enjoyed it and hoping that it will be held regularly/ yearly. The activity aims to foster camaraderie and local culture to reinforce team spirit, boost mental health and bring back the memories of childhood.

On June 20-24, 2022, CENRO Brooke's Point participated on DENR Palawan Sports fest .A total of 32 players from CENRO Brooke's Point joined the said activity. Events such as volleyball, basketball, table tennis, badminton and dart were actively played by different CENROs. 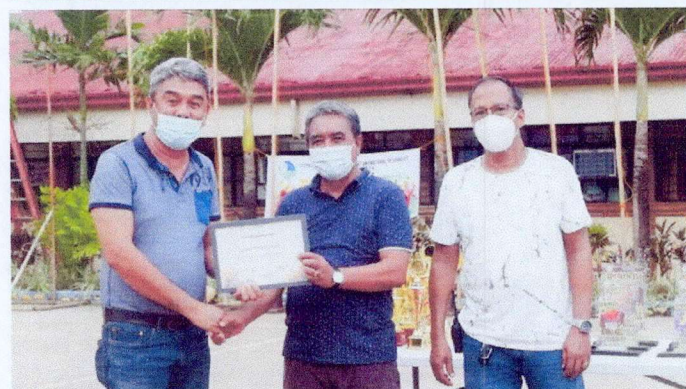

II. Youth Involvement

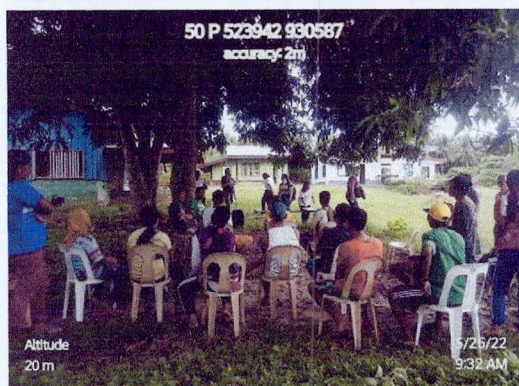

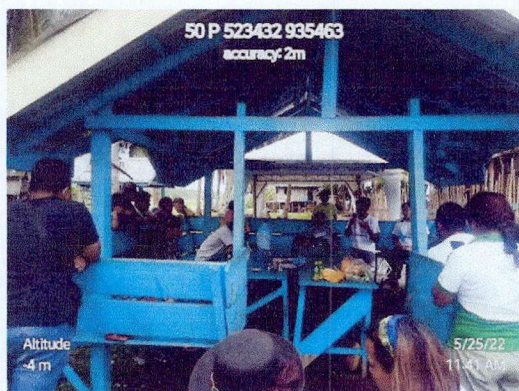
III. Forest Protection Awareness

The continuous coordination with the LGUs and IEC activities is conducted regularly to strengthen the relationship of all stakeholders and monitoring and manning of checkpoints 24/7 is being implemented. The IEC also increases awareness of the community on the importance of the forest and its benefits in their daily lives and the effects of forest destruction/ denudation including the forestry laws, rules and regulations being implemented by the DENR in the protection and conservation of our natural resources.


To further minimize the illegal activities within the identified hotspot area in the Municipality of Bataraza, series of IEC's were conducted. These activities aimed to strengthen and disseminate correct knowledge and information regarding the protection, conservation and management of environment and natural resources and capacitate Barangay LGU's and citizenry in managing their own natural resources and intensely support the priority major programs of DENR. Moreover, to address the Lands matters and environmental related issues and concern that will be arising in the barangays. Topics discussed were Importance of Mangrove and Forest, PD 705- Revised Forestry Reform Code of the Philippines, Small Scale Mining (Sand and Gravel), Forest Product Utilization and Permitting, Solid Waste Management and Land titling/ Disposition.
