SIR:

To support our request for the cancellation of the Subdivision Plan CSD-04-024890-D and the Cadastral Map of LOT 4203 CAD 800-D and the adjacent lots Puerto Princesa cadastre which I have submitted on Feb. 9, 2015, I hereby submit my investigation survey report.

The following are my findings:

- The Lot Description of Lot 4203 CAD-800-D as submitted with the approve plan does not tally or conform with its corresponding lot data computation and cadastral plan.
- Lot 4108 of the same cadastral map has seven corners while in its lot data computation,
 it has five corners. Please take note also the distances of the side 1-2 and 5-6 of lot
 4108 are far longer in the lot data computation.

To plot this lots/block on the north of Lot 4203 using lot data computation, the entire road separating this block and Lot 4203 of BLCA will be totally encroached by this block.

May I therefore reiterate my request for the cancellation of the subdivision plan CSD-04-024980-D and disregard or void the cadastral map/lot data computation.


Furthermore, may I also request the approval of the **Subdivision Plan of Lot 4203** which I have submitted based from the actual survey I made.


