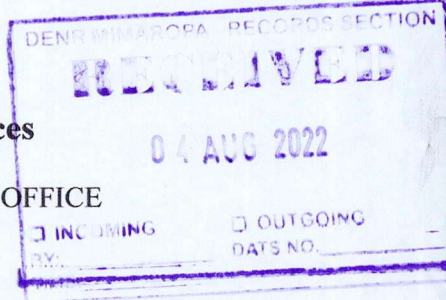

Respectfully forwarded is the memorandum of CENRO Quezon dated July 18, 2022 relative the above subject.

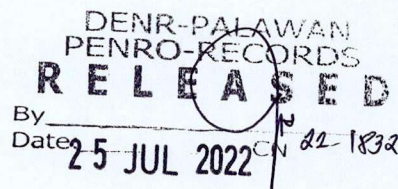
