



Submitting herewith is the after-activity report of the Coast Watch RCC-Palawan meeting held at the Regional Coordinating Council Building at Brgy. Liwanag, Puerto Princesa City on July 12, 2022.

The undersigned was instructed by OIC-CENRO Pedro Velasco to attend the above-cited meeting. The meeting was about the validation and revision of the manual of operation because according to them, it was done in 2016, and not all the attached/ member agencies as of the moment were already included. It particularly reviewed the functions and responsibilities of the liaison officers of every agency, for comments and revision.

The following are the discussed functions and responsibilities of the RCC-Palawan Liaison Officer:

- Act as a Single Point Contact (POC) of their respective agencies and shall aid the RCC-Palawan in updating the Common Operating Picture (COP) of maritime issues and concerns;
- Physically report to Chief, Information Operation Group at the RCC Palawan Building, Port Area, Brgy. Liwanag, Puerto Princesa City, Palawan on a regular basis, or whenever needed and as deemed necessary;
- Provide staff and technical expertise and advice to the RCC-Palawan on all matters pertaining to any information concerning their respective agency;
- Facilitate information sharing in accordance with approved Standard Operating Procedures (SOPs) and the Implementing Guidelines, Rules, and Regulations (GRR);
- Attend every inter-agency meeting;
- Support the development of contingency plans based on the intended interagency operations outcomes and requirements;
- Provide Subject Matter Expert (SME) advice on the specific threats when needed;
- Where requested, attend the RCC-Palawan meetings to support critical incident management and crisis planning on matters which falls under the mandate of their respective agency;

- Advice and inform their respective agency of the RCC-Palawan activities and requirements to ensure that their agency is aware of possible impacts on their agency operations and activities;
- Liaison with their respective agencies for the provision of assets, personnel, and prosecution expertise whenever necessary;
- Provide timely, accurate, and relevant maritime information, reports, and assessments to the RCC-Palawan;
- Provide responses to RCC-Palawan Maritime Information Reports (MIR);
- Provide responses to Request for Information (RFI) forwarded to their respective agencies;
- Review existing RCC-Palawan SOPs periodically to ensure that they meet the individual agency needs; and
- Ensure the confidential and proper handling of sensitive information, documents, and any transactions with the RCC-Palawan.

There were only very minimal discussion and minimal comments on the roles and functions of the liaisons and they will just incorporate the suggestions and will present the amended copy by next meeting.

After the presentation, they also mentioned that the monitoring station in Brgy. Mangingisda is now functional and there was a demonstration on how they make use of it having control at the RCC office. They also encourage member agencies like PPA, that if they need information, they can maximize the data captured by the station.



