





**COMPLETED STAFF WORK REPORT ON THE APPREHENDED
UNDOCUMENTED FOREST PRODUCTS, IN VIOLATION OF SECTION 77 OF
PD 705 AS AMENDED BY RA 7161 AND DAO 97-32, SERIES OF 1997**

I. HISTORY

The case was filed against Ms. Jessica C. Barolo, a resident of Barangay Pag-asa, Sablayan, Occidental Mindoro.

That on March 7, 2022, the joint anti-logging operation conducted by the DENR-CENRO Sablayan, Sablayan Municipal Police Station and the Philippine Army resulted to the arrest of Ms. Jessica C. Barolo who was caught transporting undocumented forest products at So. Amnay, Brgy. Pag-asa, Sablayan, Occidental Mindoro using a white Mitsubishi L300.

During the apprehension, it was found out that the accused was found transporting 5 pieces of Gmelina with a total volume of 241.67 bd ft. She was asked if she have a permit to carry the said lumber and she answered in the negative.

The DENR personnel immediately apprehended the illegal forest products. It was brought to the Office of the Provincial Prosecutor at San Jose, Occidental Mindoro for safekeeping and proper disposition.

The accused was arrested and brought to the Office of the Provincial Prosecutor at San Jose, Occidental Mindoro for inquest proceeding.

On March 8, 2022, the San Jose Regional Trial Court issued an information against Jessica C. Barolo for violation of Section 77, PD 705. The case was docketed as Criminal Case No. R-11232.

The administrative hearing for the above apprehended illegal forest products was held on March 10, 2022 at the DENR-CENRO Sablayan Main Office. Forester III Isaias A. Guimod acted as the hearing officer, assisted by EMS Chief Ariston SJ. Ramos. The accused was present and was given the chance to explain herself.

OBSERVATION/FACTS

1. That on March 7, 2022, the joint anti-logging operation conducted by the DENR-CENRO Sablayan, Sablayan Municipal Police Station and the Philippine Army resulted to the arrest of Ms. Jessica C. Barolo who was caught transporting undocumented forest products using a white Mitsubishi L300.
2. That during the apprehension, it was found out that the accused was transporting undocumented forest products. (5 pieces of Gmelina)
3. That transporting undocumented forest products is a crime under Section 77 of PD 705 as amended by RA 7161.
4. That during the administrative hearing, Ms. Barolo admitted transporting the said undocumented forest products. According to her the apprehended Gmelina lumbers were harvested from So. Mayba, Brgy. Pag-asa, Sablayan, Occidental Mindoro.
5. That according to Ms. Barolo she planned to use the apprehended Gmelina to build schools and churches on remote mountain areas.

6. That the accused was arrested and brought to the Office of the Provincial Prosecutor at San Jose, Occidental Mindoro for inquest proceeding.

7. That an Information was issued against the accused on March 8, 2022. The case was docketed as Criminal case No. R-11232.

II. SUMMARY OF ADMINISTRATIVE PROCEEDINGS

It appears that the accused was caught in transporting undocumented forest products which is in violation of Section 77 of PD 705 as amended by RA 7161.


Section 77 clearly states that transporting forest products without proper documents or permit from the proper authority is a violation under PD 705.


III. RECOMMENDATION

Sa ilalim ng saligang batas karapatan ninyo na sumagot o manahimik lamang sa mga katanungan sa inyo. Ang inyong mga sasabihin o isasagot ay maaaring gamitin pabor o laban sa inyo sa anumang hukuman. Maaari rin kayong kumuha ng inyong abogado upang magbigay gabay legal sa inyo. Kung wala naman kayong kakayahan, bibigyan kayo ng estado sa pamamagitan ng request sa Public Attorney's Office (PAO).

7. TANONG: Ano po ang inyong ikinabubuhay?

SAGOT: Wala po kaming trabaho talaga, hindi po kami empleyado pero meron po kaming livelihood na sumusuporta sa pangangailangan ng pamilya. Ang pinaka trabaho po namin ay missionaries po kami sa kabundukan.

8. TANONG: Maaari po ba ninyong ilarawan ang livelihood na sinasabi po ninyo?

SAGOT: Dahil nga po kami ay missionaries sa mga kabundukan, may schools po kami sa taas po ng bundok na hindi na po naaabot ng DEPED, inaakyat po ng almost 6 hours. Pag andito naman po ako sa baba, nagpapartime po ako na nagtitinda ng healthy foods kagaya po ng soya milk, tokwa at mga natural juices.

9. TANONG Alam ninyo po ba bakit kayo naririto ngayon sa aming tanggapan?

SAGOT: Opo.

10. TANONG: Base po sa aming report, nahulihan po kayo ng 5 pirasong kahoy, naaalala po ba ninyo kung anong mga kahoy ang mga iyon?

SAGOT: Gmelina po.

11. TANONG: Saan po nanggaling ang mga kahoy?

SAGOT: Sa So. Mayba po Brgy. Pag-asa.

12. TANONG: Iyon po ba ay tanim ninyo?

SAGOT: Tanim po ng mga katutubo.

13. TANONG: Saan po nila ito tanim?

SAGOT: Sa mga bukid po nila.

14. TANONG: Nahuli po kayo na ang mga Gmelina ay nakasakay sa isang L300, kayo po ba ang may-ari ng L300?

SAGOT: Hindi po, ang aking asawa.

15. TANONG: Mayroon po ba kayong dokumento na magpapatunay na sa asawa po ninyo nakapangalan ang sasakayan?

SAGOT: Opo, iyong lisensya ng sasakyan.

16. TANONG: Saan po ninyo balak dalhin iyong 5 pirasong Gmelina?

SAGOT: Sa bahay po.

17. TANONG: Pwede po bang malaman ang buong pangalan po ng inyong asawa?

SAGOT: Pedro Barolo.

18. TANONG: Noong March 7, 2022, sino po ang nakahuli sa inyo?

SAGOT: Ang unang apprehension po ay mga sundalo, sunod po ay mga taga DENR na.

19. TANONG: Hinanapan po ba nila kayo ng mga kaukulang papeles?

SAGOT: Opo, naghanap po sila.

20. TANONG: Meron po kayong naipakita?

SAGOT: Wala po.

21. TANONG: Alam po ba ninyo na ipinagbabawal po iyon?

SAGOT: 50/50 po kasi ang alam ko po pagdating diyan kasi nga po ay bilog pa hindi pa na chainsaw tapus pag-aari pa ng katutubo.

22. TANONG: Saan po ninyo balak gamitin ang mga kahoy?

SAGOT: Dahil nga po kami ay may mga paaralan at simbahan na tinatayo sa mga bundok, iyon po talaga ay para doon.

23. TANONG: Noong kayo po ay nahuli mag-isa lang po ba kayo?

SAGOT: Ako po at 3 katutubo.

24. TANONG: Maari po bang malaman ang kanilang mga pangalan?

SAGOT: Opo, Memo Murello, Seth Segunda at Erning Pedion.

25. TANONG: Alam po ba ninyo kung bakit hindi po sila kasama?

SAGOT: Ang rason po nila noong kasama ko pa po ang mga police at DENR, nagtanong din ako kung andiyan na po ang aking mga kasama sabi nila magkakaroon daw sila ng sariling imbestigasyon kasi sila ay may kultura may separate na batas para sa kanila kaya ibang pamamaraan iyon.

Ito po ay ambulance ng mga katutubo ibinigay lang po sa amin ito at hindi po namin alam kung sino po itong nagbigay sinalubong lang po namin sa Abra at may nagbayad po sa Mitsubishi. Dahil po kami ay missionaries marami po kaming mga villages na inaabot. Marami po kaming school na pinupuntahan pati po mga churches. Ang sasakyan po na yan ay naghahaul po ng mga pagkain ng mga teachers, ng mga missionaries kaya po napakahalaga po ng sasakyan, isa pa po pandemic ang hirap po sa mga katutubo na pumunta sa ospital pati po sa 4ps dahil po napakamahal po ng pamasaha sa tricycle.




INFORMATION

The undersigned accuses **JESSICA BAROLO y Curitana**, of Violation of Section 77, of PD 705, committed as follows:

That on or about the 7th day of March, 2022, at around 12:22 o'clock in the afternoon, in Sitio Amnay, Barangay Pag-asa, Municipality of Sablayan, Province of Occidental Mindoro, Philippines, and within the jurisdiction of this Honorable Court, the accused, with intent to gain, did then and there, willfully, unlawfully and feloniously, have in his possession, custody and control five (5) pieces round logs of gemelina, with total volume of 0.5703 cubic meter or 241.67 board feet, amounting to FOUR THOUSAND EIGHT HUNDRED THIRTY THREE PESOS AND 40/100 (P4,833.40) Philippine Currency, loaded in a MITSUBISHI L300, colored white, with Plate No. B7 P635, without any permit or authority from the Secretary of Environment and Natural Resources or his duly authorized representative, in violation of PD 705 as amended, to the damage and prejudice of the Philippine Government.

FACTS OF THE CASE:

Joint Anti-Illegal Logging Operation conducted by elements of Sablayan MPS under the supervision of the undersigned, DENR-CENRO Sablayan (lead), PIU OMPPO, 405th RMFB and Bravo Company, 76 IB, Philippine Army which resulted in the arrest of the above named suspect. Recovered from the suspect's immediate possession while on board a Color white Mitsubishi L300 Van bearing Plate Number B7 P635 were round log lumbers of Gmelina Species broken down as follows: one (1) piece of 31cm x 2.13 m marked as RSC-1; one (1) piece of 33 cm x 2.13 m marked as RSC-2; one (1) piece of 22 cm x 2.13 m

marked as RSC-3; one (1) piece of 26 cm x 2.13 m marked as RSC-4; and one (1) piece of 44 cm x 2.13 m marked as RSC-5 with a total board feet of Two Hundred Forty One and Sixty Seven (241.67 bd ft.) with estimated market value amounting to Four Thousand Eight Hundred Thirty Three and Four Pesos (Php 4, 833.4) Philippine Currency. The recovered pieces of evidence were inventoried and scaled by the personnel of DENR-CENRO Sablayan, Occidental Mindoro. Thereafter, arrested suspect was apprised of her Constitutional Rights (Miranda Warning and Anti-Torture Law). Furthermore, the arrested suspects were brought to this station together with the recovered pieces of evidence for proper disposition.

Based on the foregoing facts, a case of Violation of PD 705 will be brought to the attention of Duty Prosecutor for scrutiny and recommendation. This case will be presented to you by PSSg Rolando D Sales Jr., Investigator-On-Case.
