The concerned employee has informed this Office of his intention to resign from the government service for personal reason, copy of the document is hereto appendix as Annex A.

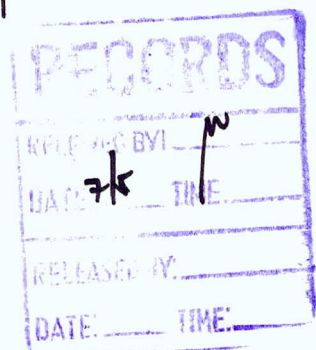
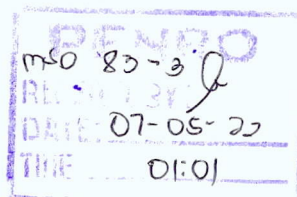
Upon receipt of his letter resignation, we immediately called his attention to surrender all government properties issued to him before we could further act on his request, copy attached as Annex B.
