

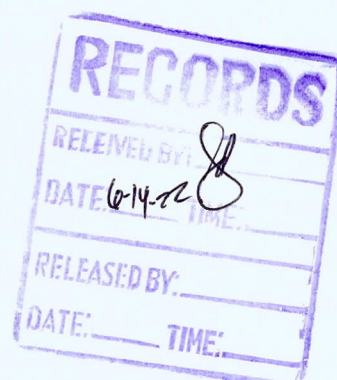


This pertains to the Forest Land Use Agreement for Tourism (FlagT) Purposes (Bathing Establishment) No. DENR-4B-02282031-0003, made and entered into by and between the OIC, ASEC for Field Operations, Concurrent Regional Executive Director of DENR-MIMAROPA Region, Vicente S. Paragas, CESO III as the Lessor and Benjamin C. Salamat as the Lessee, located at Ambil Island, Brgy. Tambo, Looc, Occidental Mindoro.

Based on DENR Administrative Order (DAO) No. 2004-28, dated August 25, 2004, the performance of FlagT Holder shall be monitored and evaluated periodically to ensure compliance to the terms and conditions of the FlagT as well as payments of government shares and other financial obligations related to the tenurial instruments.
