

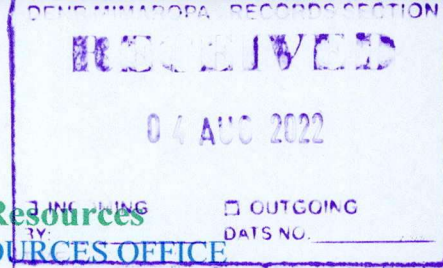

This has reference to your letter dated June 21, 2022 and received by the undersigned on June 24, 2022 with the instruction to explain in writing under oath the complaint for alleged unbecoming/ misconduct as a government employee file by a certain Elbert Reynoso.

To start, Mr. Elbert Calamba Reynoso is my neighbor at Tambis Road, Barangay San Jose, Puerto Princesa City. He is the owner of Villa Alexia Place located on the same place mentioned above and currently operating without the required Mayor's Permit for Calendar Year 2022. Since the start of their operation, we were already experiencing problems pertaining to their improper parking of vehicles including those of their guests and undesirable noises that last up to midnight. Despite repeated request to park properly, the complainant did not even bother to act on the said request.

Now, on the recent issue. The incident complained about occurred last June 19, 2022. Mr. Reynoso alleged that my son badmouthed him in front of their guests and staff of Villa Alexia Place. If we examine their evidence, their allegations and the statements of their witnesses shows evident bias and should not be favored. The witnesses who testified has obvious reasons to favor Elbert Calamba Reynoso, being their guest and staff. As such, they are not credible witnesses with unbiased observation on the events that occurred on June 19, 2022. Moreover, the complainant and the witnesses did not allege that I am the one who committed the acts complained of. It is not surprising because I am not even present at the place of the alleged incident. Obviously, their intention is to make false claim against me. However, making false claim against someone is defamatory and a clear harassment.


With regards to the issue of abuse of power, I say that I did not abuse my limited powers of my position and my office. There is no doubt that I did nothing but to let the authorities (Barangay LGU) handle the situation. If my actions were truly unbecoming of a public official, I would not entrust the resolution of the issues to the authorities. Maybe the complainant do not have a clear understanding of the meaning of abuse of power. By being a government official does not necessarily mean that I have no rights

to make complaints and seek the help of the authorities whenever my rights and the rights of my family are being violated. Notwithstanding that my house was stoned four (4) times dated June 20, 2022 after the incident which we also seek the assistance of the Barangay LGU and Philippine National Police.

It is equally important to note that I have filed a blotter/complaint with the Barangay Government of San Jose at around 10:22 PM of June 19, 2022. The complaint is all about the improper parking of vehicles owned by the guests of Villa Alexia Place. What is surprising is that they are even operating without Mayor's Permit. A flagrant violation of the law indeed. My lawyer is likewise preparing a case against Mr. Reynoso. I will not let anyone ruin my good reputation and tarnish my years of good service in the government.

Attached in this letter are the copies of the images and document which will support my claim and clear my name.

Thank you for providing me the opportunity to explain my side.

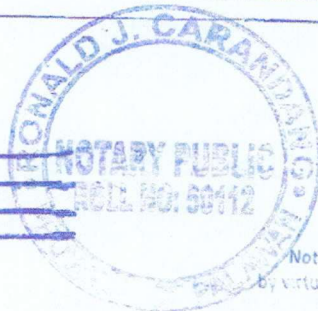

Please be informed that as per Philippine National Police list of allowed and prohibited fireworks published in the article dated December 17, 2021 by Pilgrim Nepomuceno of Philippine News Agency enumerated Judas's Bell under fireworks that are regulated to and use along with Baby Rocket, Paper Cans, Sky Rocket (Kaltis) etc. Likewise, the said fireworks was purchased in a legal source and from legal stores designated by The City Police of Puerto Princesa. Hence, and again the complaint is baseless and meant to stay name and reputation.

With regards to his previous emailed complaint on February 2021, the matter was already answered by the undersigned dated February 16, 2021 thru emails addressed also to different agencies which he (Mr. Reyoso) sent his complaint.

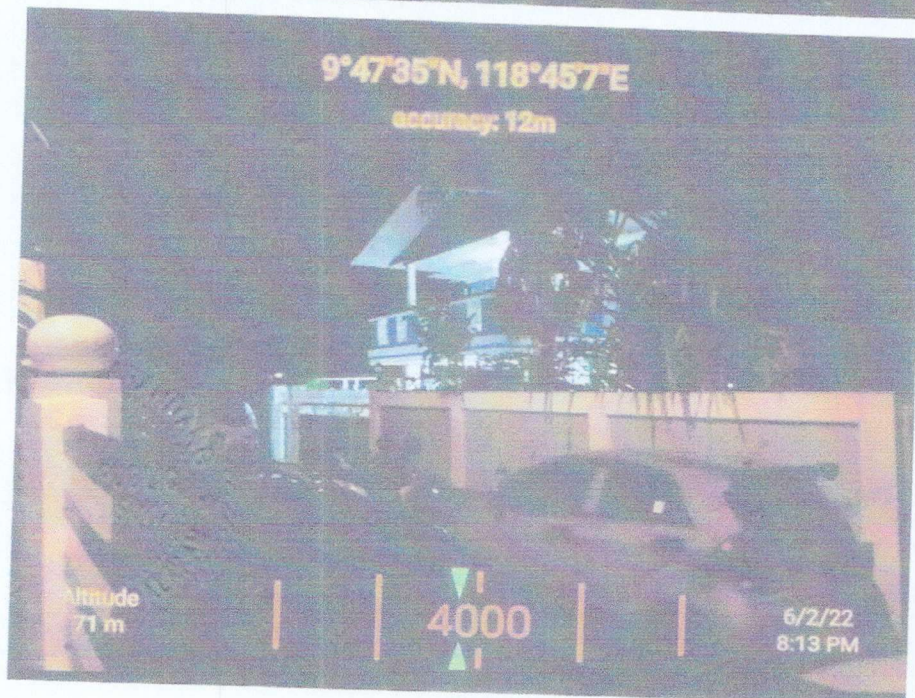




