Respectfully submitted is the report of the undersigned re the above-mentioned subject.

The meeting was conducted on July 21, 2022 at 1:30 in the afternoon in line with Establishment of PPIA Wildlife Hazard Management Committee. The meeting was led by Engr. Florevic Sonota of PPIA and attended by the undersigned and ECOMS I Arlene Basaya of CENRO Puerto Princesa and other participants from different stakeholders.

Engr. Florevic Sonota welcomed the participants and presented the PPIA Wildlife Hazard Management Committee that was established before the pandemic started. She gave a brief background regarding bird and wildlife strike and reechoed each stakeholders' duties. She also discussed some of their initiatives taken in preventing bird and wildlife strike. Their canals in the PPIA runway were installed with nets and they just shoosed away the birds that they are spotting, they were not using guns and other tools yet because they wanted to know from PCSDS and DENR when it comes to proper handling of birds and wildlife.

ECOMS I Arlene Basaya suggested that Katala Foundation Inc. may be and should be part of the committee since Ma'am Indira knows more about the proper handling of Katala and other birds. The undersigned also suggested the need to conduct quarterly waterbirds and forest birds monitoring within the vicinity of the PPIA. To address the concerns regarding bird strikes, we must first try to study what kind of birds are present within and migrating from/near the PPIA. The PPIA staff said that they already have baseline study of birds present within the PPIA conducted by NGOs and that they will give us copies of the said study.

The meeting lasted for two hours and a half and was closed after confirming the names of the members of the established management committee. CDS Chief, Rhodora B. Ubani of
