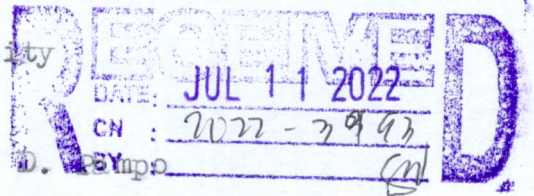



Greetings! My client, **ERLINDA N. SUMULAT KA NA LANG O MAG-FILE KA NG KASO." Other individuals were present when the shouting incident happened.

My client, who is not accustomed to such a scenario, just left the premises of the DENR office.

Upon further inquiry, my client also learned that said DENR office was, more often than not, being utilized as a drinking spot in the evening until the wee hours of the night. The drinking sprees were noisy and unruly. The unwarranted desecration of the said DENR office was reduced to minimal when my client




arrived and stayed in her property for about three weeks from the third week of April to the first week of May 2022.

Based on the foregoing, it is our firm contention that this **REY PAMPO** has no right to occupy any position for that matter within the DENR and he should be purged from your ranks if only to safeguard the good name of your Department.
