# **RESOLUTION No. 2022-041**

This pertains to the apprehension of abandoned One (1) Unit of Chainsaw STIHL, with no serial number with Oregon guide bar at So. Quintal, Brgy. Murtha, San Jose, Occidental Mindoro, on March 8, 2022, at around 01:07 in the afternoon by the Personnel from Enforcement and Monitoring Section (EMS) by the DENR CENRO, San Jose, Occidental Mindoro

# The facts of the subject case are as follows, to wit:

- That on March 8, 2022, while conducting LAWIN Patrolling within the vicinities of Sitio Quintal, Brgy. Murtha, San Jose, Occidental Mindoro, the EMS team encountered an illegal cutting activity where the perpetrator was able to escape and left/abandoned One (1) Unit of Chainsaw STIHL, with no serial number with Oregon guide bar. The said chainsaw unit was considered as abandoned. (Please see attached)
- 2. That the apprehended One (1) Unit of Chainsaw STIHL, with no serial number with Oregon guide bar, was temporarily impounded at the custody of the DENR CENRO office, San Jose Occidental Mindoro, for safekeeping. (please see attached apprehension receipt)
- 3. That the corresponding Apprehension Receipt with CENRO Control No.2022-F437 was issued and signed by the apprehending officer Forest Range Carl Emmanuel Urieta (please see attached apprehension receipt)
- 4. That after verifying the existence of a prima facie case against the offender, the Seizure Officer Forester III Hector S. Aragones, Jr. issued the Seizure Order with CENRO Control Number 2022-F437 for the One (1) Unit of Chainsaw STIHL, with no serial number with Oregon guide bar (please see attached seizure order)
- 5. That a PABATID SA PUBLIKO (Notice to the Public) was posted in conspicuous places such as So. Quintal, Brgy. Murtha and at the Brgy. Hall of Barangay Murtha, San Jose, Occidental Mindoro. (please see attached pabatid sa publiko)
- 6. That no Notice of the Administrative Hearing was made because the One (1) Unit of Chainsaw STIHL, with no serial number with Oregon guide bar was Abandoned.

### The issues to be resolved in this case are as follow;

1. Whether or not, the apprehended One (1) Unit of Chainsaw STIHL, with no serial number with Oregon guide bar. Shall be confiscated in favor of the government.

The grounds for apprehension and seizure of the Unregistered Chainsaw is valid, as the apprehended Chainsaw Unit is unregistered and it has no record that it is issued by the office of the DENR CENRO San Jose, Occidental Mindoro.

Presidential Decree No. 9175, November 7, 2002, AN ACT REGULATING THE OWNERSHIP, POSSESSION, SALE, IMPORTATION AND USE OF CHAINSAWS, PENALIZING VIOLATIONS THEREOF AND FOR OTHER PURPOSES, states that;

**SECTION 7.** Cutting, Gathering and/or collecting Timber, or Other Forest Products Without License. – Selling, Purchasing, Re-selling, Transferring, Distributing or Possessing a Chain Saw Without a Proper Permit. - Any person who sells, purchases, transfer the ownership, distributes or otherwise disposes or possesses a chain saw without first securing the necessary permit from the Department shall be punished with imprisonment of four (4) years, two (2) months and one (1) day to six (6) years or a fine of not less than Fifteen thousand pesos (P15,000.00) but not more Thirty thousand pesos (30,000.00) or both at the discretion of the court, and the chain saw/s confiscated in favor of the government.

SECTION 14. DAO 2003-04. – CONFISCATION OF CHAINSAWS. – Chainsaws used in the cutting, gathering, collecting, removing and/or processing timber or forest products without legal documents shall be subject to Judicial and/or administrative confiscation under Section 68 and 68A of PD 705 as amended, and as implemented by DAO 97-32 and other subsequent forestry regulations that may be promulgated.

Department Administrative Order No. 2003-04

Sec. 12. Items subject to apprehension, seizure, confiscation and forfeiture.

12.1 SELLING, PURCHASING, RE-SELLING, TRANSFERRING, DISTRIBUTING, OR POSSESSING, A CHAINSAWA WITHOUT A PROPER PERMIT- Any person who sells, purchases, transfers the ownership, distributes, or otherwise disposes or possess a chainsaw without first securing the necessary permit from the Department shall be punished with imprisonment of four (4) years, two (2) months and one (1) day to six (6) years or a fine of not less that Fifteen Thousand (15,000) pesos but not more than Thirty Thousand Pesos (P30,000.00) or both at the discretion of the court and the chainsaw confiscated in favor of the government

### **DEPARTMENT ADMINISTRATIVE ORDER 97-32**

#### Sec. 8. Abandoned Illegal Forest Products.

The following procedures apply in cases where illegal forest products and other items listed in Section 2 hereof are abandoned, or when the owner, claimant, custodian or other interested Patry(ies) is unknown, cannot be determined, or cannot otherwise be found.

Par.3. Summary Seizure/Confiscation Proceedings shall be conducted by the hearing officer designated in these rules. In such cases the Notice of Hearing shall be posted at least three (3) times, once a every week for three (3) consecutive weeks, in at least three (3) public places, including but not limited to: (a) the Barangay Hall of the apprehension

site; (b) the Bulletin Board of the DENR Offices where the Proceedings will be conducted, and (c) at the Municipal Hall of the apprehension site.

Should the owner, claimant or other interested Party fail to appear at the Proceedings, such failure shall be deemed a waiver of the right to appear and of any/all rights to the items apprehended in favor of the Government.

### Sec.13 THE FOLLOWING CHAINSAW ARE SUBJECT TO CONFISCATION

13.1. Chainsaws sold, purchased, resold, transferred, distributed, leased, rented, lent or **possessed** without proper permit or authority from the Department.

2. The enumerated statements of facts, pieces of evidence and circumstances surrounding the above stated case, shows that the apprehended One (1) Unit of Chainsaw STIHL, with no serial number with Oregon guide bar. Shall be confiscated in favour of the government since the chainsaw subject to illegal used in cutting forest products is unregistered at the office of the DENR CENRO San Jose Occidental Mindoro.

Based in the case at bar, the Mere fact that a Chainsaw is without proper registration and documentation issued by the Office of the DENR CENRO San Jose Occidental Mindoro, if proven is a violation of Section 7 of PD 705 and the DENR DAO 2003-04 section 12.1 and 13.1, thus subject to confiscation. Moreover, in occasion where the said illegal forest products was said to be abandoned it shall also be confiscated in favor of the Government, under Section 8 Par. 3 of Department Administrative Order (DAO) 97-32.

WHEREFORE, pursuant to Section 7 of PD 705 and the DENR DAO 2003-04 section 12.1 and 13.1, thus subject to confiscation the following are hereby recommended:

3. That the APPREHENDED One (1) Unit of Chainsaw STIHL, with no serial number with Oregon guide bar, shall be confiscated in favour of the government, since the chainsaw in the possession of the accused is not registered and no records of it was found in the Office of the DENR CENRO, San Jose Occidental Mindoro.

OCCIDENTAL MINDORO ON MARCH 8, 2022

Please be informed that the personnel of Enforcement and Monitoring Section led by Forest Ranger Carl Emmanuel A. Urieta together with Forest Ranger Tristan V. Rendorio, Forest Ranger Ronald Fresnillo, FPO Louie D. James Antonio, FPO Leizle S. Andrade, FPO Ednor C. Legaspi, Jr. and FPO Elmer Salongsongan had conducted LAWIN Patrolling within the vicinities of So. Quintal, Brgy. Murtha, San Jose, Occidental Mindoro.

On the same date, around 1:07 in the afternoon during the patrol, the undersigned has encountered illegal activity in resulting to apprehension of one (1) unit of chainsaw. As per verification, the said equipment has not been registered at DENR CENRO San Jose, Occidental Mindoro and has no serial number therefore, considered as illegal operated and clearly violation of Section 7 paragraph 4 of Republic Act 9175 known as "Chainsaw Act of 2002".

That upon apprehension, FR Rendorio called and coordinate with Chief EMS, Forester III Hector S. Aragones, Jr. Immediately thereafter, For. III Aragones asked for assistance to San Jose MPS in order to arrest the culprit. But before the PNP personnel and EMS Staff arrived the perpetrator does not want to disclose his identity and a commotion succeeded were the culprit and FPO Salongsongan are forcing each other to fight for the possession of the said chainsaw and the said culprit about to draw his bolo. During the commotion the culprit realized that his actions may be useless and decided to ran away. Hence, for the safety, the team decided to carry the said equipment and proceed to BLGU of Murtha, San Jose, Occidental Mindoro to file blotter report of the incident and to identify the perpetrator, but still the Brgy. Officials cannot recognized the culprit on the photo presented by the undersigned.

Be further informed that the said chainsaw were brought to the DENR CENR Office for safe keeping and proper documentation.


