Lucia o mas kilala sa tawag na Halaohaoan Carindan sa Sablayan, Occidental Mindoro.

1. Kami po ay humihiling ng mga kaukulang kopya at pagsertipika sa mga dokumento patungkol sa lupang ito.
2. Kami ay bigyang pahintulot na mapaimbistigahan at maibalik sa amin ang maliit na lawa na sakop sa orihinal na apply ng aming lolo, kaugnay sa pag ukupa ng Pamahalaan ng Barangay Sta. Lucia ngayon at pagpaparenta nito sa mga pribadong tao ng nakaraang administrasyon ng Barangay na hindi katanggap tanggap para sa amin bilang nagmamay-ari nito.
3. Na, sa mula at simula ito po ay inalagaan ng aming tenant na yumaong si G. Antonio Florida, inalpasan ng mga may lahing similya ng Tilapia, Karpa, Barungis, Igat, Hipon at Tulya na galling pa sa ibat ibang lake at ibat ibang uri ng similya na mapahanggang sa ngayon ito ay napapakinabangan ng

Barangay Opisyal ng aming Barangay sa kanilang mga pansariling kapakinabangan.

4. Na, si G. Andy Florida na anak ng aming tenant ay isa sa saksi sa hirap at nagtiyaga sa pag aalpas ng mga similyang isdang nabanggit sa maliit na lawa nito, na para sana sa kapakinabangan namin bilang naiwan ng aming yumaong lolo at ng ibang risidente dito na makapangisda sila ng libre at walang bayad na hindi tulad ngayon na may mga kondisyonis na ipinapataw ang pamahalaang Barangay Sta. 1. I, the undersigned, hereby make application to purchase under the provisions of Chapter V, or IX of Commonwealth Act No. 141 (The Public Land Act as amended), the tract of public land for agricultural, residential, commercial or industrial purposes described as follows:

~~The tract of land described in lot No. 141, in the parish of San Juan, municipality of Calatagan, province of Batangas, Island of Luzon, Philippines, has been divided and bounded as follows: On the North by lots Nos. 2064 & 2065, on the South by lot No. 2067, to the East by lots Nos. 2061 and on the West by lots Nos. 2065 & 2066, all of Piso-14, San Juan, Que. ~~Situated in the barrio of Barrio, municipality of Calatagan, province of Batangas, Island of Luzon, Philippines, and containing an area of 14.0000 Hectares the shape and dimensions of said tract being as indicated in the accompanying sketch on the back of this application.~~

2. My name is JUANITO RAMOS; my age is 40 years; I was born on May 1, 1898, and my post office address is Calatagan, Que. Batangas. I am married, single, and the name of my wife, husband is Julia, who is a citizen of the Philippines.
