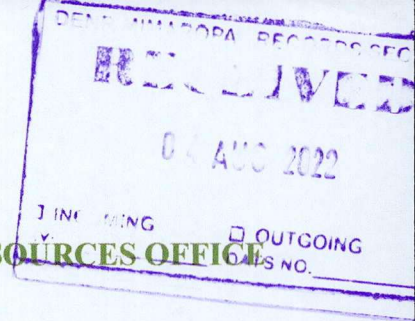

**RESOLUTION No. 2022-043**

This pertains to the apprehension of abandoned One (1) Unit of Chainsaw STIHL, with no serial number with OREGON guide bar at So. Barombong, Brgy. Mapaya, San Jose, Occidental Mindoro, on May 19, 2022, at around 04:45 in the afternoon by the Personnel from Enforcement and Monitoring Section (EMS) by the DENR CENRO, San Jose, Occidental Mindoro

**The facts of the subject case are as follows, to wit:**

1. That on May 19, 2022, the Enforcement and Monitoring Section (EMS) Team of the DENR conducted monitoring and surveillance within the vicinity of Brgy. Mapaya, San Jose, Occidental Mindoro. EMS team encountered an illegal cutting activity where the perpetrator was able to escape and left/abandoned One (1) Unit of Chainsaw STIHL, with no serial number with OREGON guide bar. The said chainsaw unit were considered as abandoned. *(Please see attached)*
2. That the apprehended One (1) Unit of Chainsaw STIHL, with no serial number with OREGON guide bar, was temporarily impounded at the custody of the DENR CENRO office, San Jose Occidental Mindoro, for safekeeping. *(please see attached apprehension receipt)*
3. That the corresponding Apprehension Receipt with CENRO Control No. 2022-F446 was issued and signed by the apprehending officer Deputy Chief EMS. Forester I Jomar B. Serquina *(please see attached apprehension receipt)*
4. That after verifying the existence of a prima facie case against the offender, the Seizure Officer Forester III Hector S. Aragon, Jr. issued the Seizure Order with CENRO Control Number 2022-F446 for the One (1) Unit of Chainsaw STIHL, with no serial number with OREGON guide bar *(please see attached seizure order)*
5. That a PABATID SA PUBLIKO (Notice to the Public) was posted on May 20, 27 and June 03, 2022 in conspicuous places such as So. Barombong, Brgy. Mapaya and at the Brgy. Hall of Barangay Mapaya, San Jose, Occidental Mindoro. *(please see attached pabatid sa publiko)*



6. That no Notice of the Administrative Hearing was made because the One (1) Unit of Chainsaw STIHL, with no serial number with OREGON guide bar was Abandoned.

**The issues to be resolved in this case are as follow;**

1. Whether or not, the apprehended One (1) Unit of Chainsaw STIHL, with no serial number with OREGON guide bar. **Shall be confiscated in favor of the government.**

The grounds for apprehension and seizure of the Unregistered Chainsaw is valid, as the apprehended Chainsaw Unit is unregistered and it has no record that it is issued by the office of the DENR CENRO San Jose, Occidental Mindoro.

Presidential Decree No. 9175, November 7, 2002, **AN ACT REGULATING THE OWNERSHIP, POSSESSION, SALE, IMPORTATION AND USE OF CHAIN SAWS, PENALIZING VIOLATIONS THEREOF AND FOR OTHER PURPOSES**, states that;

***SECTION 7. Cutting, Gathering and/or collecting Timber, or Other Forest Products Without License. – Selling, Purchasing, Re-selling, Transferring, Distributing or Possessing a Chain Saw Without a Proper Permit. -*** Any person who sells, purchases, transfer the ownership, distributes or otherwise disposes or possesses a chain saw without first securing the necessary permit from the Department shall be punished with imprisonment of four (4) years, two (2) months and one (1) day to six (6) years or a fine of not less than Fifteen thousand pesos (P15,000.00) but not more Thirty thousand pesos (30,000.00) or both at the discretion of the court, and the chain saw/s confiscated in favor of the government.

***SECTION 14. DAO 2003-04. – CONFISCATION OF CHAINSAWS. –*** Chainsaws used in the cutting, gathering, collecting, removing and/or processing timber or forest products without legal documents shall be subject to Judicial and/or administrative confiscation under Section 68 and 68A of PD 705 as amended, and as implemented by DAO 97-32 and other subsequent forestry regulations that may be promulgated.

Department Administrative Order No. 2003-04

***Sec. 12. Items subject to apprehension, seizure, confiscation and forfeiture.***

***12.1 SELLING, PURCHASING, RE-SELLING, TRANSFERRING, DISTRIBUTING, OR POSSESSING, A CHAINSAW WITHOUT A PROPER PERMIT-*** Any person who sells, purchases, transfers the ownership, distributes, or otherwise disposes or possess a chainsaw without first securing the necessary



*permit from the Department shall be punished with imprisonment of four (4) years, two (2) months and one (1) day to six (6) years or a fine of not less than Fifteen Thousand (15,000) pesos but not more than Thirty Thousand Pesos (P30,000.00) or both at the discretion of the court and the chainsaw confiscated in favor of the government*

#### **DEPARTMENT ADMINISTRATIVE ORDER 97-32**

##### **Sec. 8. Abandoned Illegal Forest Products.**

*The following procedures apply in cases where illegal forest products and other items listed in Section 2 hereof are abandoned, or when the owner, claimant, custodian or other interested Party(ies) is unknown, cannot be determined, or cannot otherwise be found.*

*Par.3. Summary Seizure/Confiscation Proceedings shall be conducted by the hearing officer designated in these rules. In such cases the Notice of Hearing shall be posted at least three (3) times, once a every week for three (3) consecutive weeks, in at least three (3) public places, including but not limited to: (a) the Barangay Hall of the apprehension site; (b) the Bulletin Board of the DENR Offices where the Proceedings will be conducted, and (c) at the Municipal Hall of the apprehension site.*

*Should the owner, claimant or other interested Party fail to appear at the Proceedings, such failure shall be deemed a waiver of the right to appear and of any/all rights to the items apprehended in favor of the Government.*

##### **Sec.13 THE FOLLOWING CHAINSAW ARE SUBJECT TO CONFISCATION**

*13.1. Chainsaws sold, purchased, resold, transferred, distributed, leased, rented, lent or **possessed** without proper permit or authority from the Department.*

2. The enumerated statements of facts, pieces of evidence and circumstances surrounding the above stated case, shows that the apprehended One (1) Unit of Chainsaw STIHL, with no serial number with OREGON guide bar. **Shall be confiscated in favour of the government since the chainsaw subject to illegal used in cutting forest products is unregistered at the office of the DENR CENRO San Jose Occidental Mindoro.**

Based in the case at bar, the **Mere fact that a Chainsaw is without proper registration and documentation** issued by the Office of the DENR CENRO San Jose Occidental Mindoro, if proven is a violation of Section 7 of PD 705 and the DENR DAO 2003-04 section 12.1 and 13.1, thus subject to confiscation. Moreover, in occasion where the said illegal forest products was said to be abandoned it shall also be confiscated in favor of the Government, under Section 8 Par. 3 of Department Administrative Order (DAO) 97-32.

**WHEREFORE**, pursuant to Section 7 of PD 705 and the DENR DAO 2003-04 section 12.1 and 13.1, thus subject to confiscation the following are hereby recommended:



3. That the APPREHENDED One (1) Unit of Chainsaw STIHL, with no serial number with OREGON guide bar, shall be confiscated in favour of the government, since the chainsaw in the possession of the accused is not registered and no records of it was found in the Office of the DENR CENRO, San Jose Occidental Mindoro.






Be further informed that the said chainsaw were brought to the DENR CENR Office for safe keeping and proper documentation.


