The nursery was established in 2013 and is still operational up to the present. The lot area of the nursery is approximately 300 square meters. The estimated seedling capacity of the nursery is around 10,000 seedlings. It is used as depository of tree seedling replacement from the Department of Public Works and Highways DPWH and other permittees.
