

- 6. That, upon inspection, the undersigned observed that the following errors appear on the subject certificate of title when compared with the approved subdivision plan, researched documents, and technical computations:
 - a. The adjoining lot along line 1-2 is "Lot 5368-B-2-F-4-G-4-D" but should be "Lot 5368-B-2-F-4-G-4-<u>C</u>";
 - b. The adjoining lot along line 4-1 is indicated as "Lot 5468-B-2-F-4-G-4-D-2" but should be "Lot 5**3**68-B-2-F-4-G-4-D-2";
 - c. The bearing of the tie line is "N.37 deg. 08'W." but should be "N.37 deg. 07'W.";
 - d. The direction of line 2-3 is SE but should be SW;
 - e. The polygon does not close and the corresponding error in the computed area is about two (2) square meters;

- 7. That, through the undersigned, petitioner had filed a request with the Technical Services of the Department of Environment and Natural Resources MIMAROPA (DENR Region IV-B) for the administrative correction of the foregoing errors in the technical description appearing on approved plan Psd-045215-068903;
- 8. On December 18, 2019, the Assistant Regional Director for Technical Services of DENR Region IV-B issued an order of amendment of plan Psd-045215-068903. (A copy of Amendment Order No.0202-2019 is made an integral part of this Petition as ANNEX "B");
- 9. To rectify the observed errors and pursuant to Amendment Order No.0202-2019, the narrative technical description of the subject lot now appears as follows:

19. That, the foregoing petition is based on Section 108 of Presidential Decree No. 1529, which states:

Section 108. Amendment and alteration of certificates. No erasure, alteration, or amendment shall be made upon the registration book after the entry of a certificate of title or of a memorandum thereon and the attestation of the same be Register of Deeds, except by order of the proper Court of First Instance. A registered owner of other person having an interest in registered property, or, in proper cases, the Register of Deeds with the approval of the Commissioner of Land Registration, may apply by petition to the court upon the ground that the registered interests of any description, whether vested, contingent, expectant or inchaate appearing on the certificate, have terminated and ceased; or that new interest not appearing upon the certificate have arisen or been created; or that an omission or error was made in entering a certificate or any memorandum thereon, or, on any duplicate certificate; or that the same or any person on the certificate has been changed; or that the registered owner has married, or, if registered as married, that the marriage has been terminated and no right or interests of heirs or creditors will thereby be affected; or that a corporation which owned registered land and has been dissolved has not convened the same within three years after its dissolution; or upon any other reasonable ground; and the court may hear and determine the petition after notice to all parties in interest, and may order the entry or cancellation of a new certificate, the entry or cancellation of a memorandum upon a certificate, or grant any other relief upon such terms and conditions, requiring security or bond if necessary, as it may consider proper; Provided, however, That this section shall not be construed to give the court authority to reopen the judgment or decree of registration. and that nothing shall be done or ordered by the court which shall impair the title or other interest of a purchaser holding a certificate for value and in good faith, or his heirs and assigns, without his or their written consent. Where the owner's duplicate certificate is not presented, a similar petition may be filed as provided in the preceding section. (Emphases supplied) xxx

WHEREFORE, it is most respectfully prayed that the technical descriptions appearing on Transfer Certificate of Title No. T-143460 be corrected as appearing in the correct narrative technical description herein presented. 



Record shows that Lot 5368-B-2-F-4-G-4-D-1-C, Psd-04-034004 registered in the name of Maria Bautista situated in Brgy. Poblacion, Victoria, Bongabon, Or. Mindoro was surveyed by Engr. Alfonso A. Bermudez on November 20, 1993 and thereafter submitted to this office for verification and approval on February 3, 1994. Consequently, subdivision plan denominated as Psd-045215-068903 was approved on March 10, 1994.

In a letter dated September 24, 2019, G.E./Atty. Norileisha R. Atienza, Atty.-in-Fact of Jane B. Roxas requested for the amendments/corrections on the subdivision plan Psd-045218-068903 and to issue narrative technical description of *Lot* 5368-B-2-F-4-G-4-D-1-G-5 which shall be annexed to the subsequent Petition for Correction of technical description to be filed with the appropriate Regional Trial Court. The undersigned has observed the following to wit;

- 1. The lot number of the property as indicated on both the approved plan and the certificate of title is *Lot* 5368-B-2-F-4-G-4-D-1-G-5. It is observed that the name of the lot from which this property was subdivided is *Lot* 5368-B-2-F-4-G-4-D-1-C, *Psd-04-034004*. The other lots in the plan are as well culled from "Lot 5386" except Lots 5368...C-4 and 5368...C-5. However, it is also observed that adjoining lots on plan are plotted as "Lot 5366", "Lot 5368-B-2-F-4-D-4-C, Psd-04-012302", "Lot 5368-B-2-F-4-D";
- 2. The direction of line 2-3 of Lot 5368-B-2-F-4-G-4-D-1-G-5 as indicated on plan is SE instead of SW which is the correct direction;
- 3. The bearing of line 3-4 of Lot 5368-B-2-F-4-G-4-D-1-G-5 is N.16-43W. instead of N.10-43W. which is the bearing of its congruent line (line 2-3 of Lot 5368-B-2-F-4-G-4-D-1-G-4).

Verification of the existing records on file of survey plan *Psd-045215-068903* shows that the computed area of *Lot 5368-B-2-F-4-G-4-D-1-G-5* is *752 sq.m.* instead of *750 sq.m.* as appearing on the approved plan, hence necessary adjustment should be applied to wit;


Relatively, the correct Lot No. should be Lot 5368 instead of Lot 5386 as appearing inconsistently in the approve plan.
