

FACTS:

This office received referral from LMO III Allan T. Sendiong, Chief, Regulation and Permitting Section received dated July 29, 2022 a letter from the heirs of Julian Condes. Attachment is Tax Declaration and sketch of their claim.

ACTION:

On even date, the undersigned had verified in the Cadastral Map the status base on the sketch plan that they submitted and has determine on the map the adjacent lot of their claims. The submitted tax declaration has no Cadastral lot number and only the reference is the sketch that they have submitted.

FINDINGS

Base on the record on file has ascertained the following, to wit:

- 1. Base on the record, the survey claimant of lot 472 is Maria Gado. and lot 471, the listed survey claimant is Consolacion Tandog.
- 2. That the identified lot 472, Cad 589, San Jose Cadastre located at Brgy. Poblacion, San Jose, Romblon is a tilted property in favor to Maria Gado with an area of 16,259 sq.m.
- 3. That lot 472 Cad 589 situated in the same Barangay is covered by Sub-division plan and issued patents to individual applicants. (copy is hereto attached).

SUGGESTIONS/RECOMMENDATIONS:

- 1. That heirs of Julian Condes has to coordinate to the municipal assessor of San Jose, Romblon if the tax declaration issued to Julian Condes is still exists in their office.
- 2. Hrs. of Julian Condes has to submit a copy of tax declaration with cadastral lot no. to determine the location of their claims in the cadastral map.
- 3. For any query, please coordinate to this office whatever information needs of Hrs. of Julian Condes.

4. Relocation of the subject lot is necessary in order to determine its metes and bounds wherein they will hire their own chosen private Geodetic Engineer to conduct the survey.


